Thence along new lines created by this survey the following two (2) courses:

- 1. North 14°03'27" West, 287.64 feet to an iron pin set, passing an iron pin set at 68.53 feet;

Thence South 86°27'05" East, 609.12 feet along the south line of U.S.A. (DB 299-11) to a 6" mag nail set in an old road bed, passing an iron pin set at 588.23 feet;

Thence leaving said old road bed and along a common boundary to Maloney (OR 603-326) the following three (3) courses:

- 1. North 82°00'27" West, 116.53 feet to an iron pin set;
- 2. **South 13°34'51" West, 225.47 feet** to an iron pin found with a Robinson cap, passing an iron pin found with a Robinson cap at 95.16 feet;
- 3. South 12°46'17" East, 112.69 feet to an iron pin found with a Robinson cap in the northern right of way Wolfe Bennett Rd (CR 73);

Thence along said road **North 81°30'12"** West, 253.09 feet along a common boundary to U.S.A. (DB 299-11) to the point of beginning and containing 5.149 acres of which 3.469 acres is in Section 27 and 1.680 acres is in Section 28.

Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed Stevens, PS 8716.
