DESCRIPTION OF 0.464 ACRE TRACT ALL OF THE PROPERTY OF CHARLES A. COHARA & JULIE A. COHARA

The following described tract is located in River Lots #658 and #659, Section #36, Township #12 North, Range #15 West, York Township, Athens County, Ohio. Being all of Charles A. Cohara & Julie A. Cohara (Tract One & Tract Two) as recorded in Official Record 404 at Page 1761 and being more accurately described as follows;

Beginning at a stone found at the northeast corner of Section #36, thence South 29°08'44" West, a distance of 3,212.36 feet to a 5/8" rebar with no cap found at a westerly corner of Thomas E. Fearns' tract as recorded in Official Record 569 at Page 631 and being the TRUE POINT OF BEGINNING for the herein described tract;

Thence along the westerly line of Fearns' tract, South 31°14'02" East, a distance of 148.76 feet to a point on the northerly right of way of Scenic Lane (TR #279, no R/W width found), passing a 5/8" rebar with no cap found at a distance of 141.40 feet;

Thence along the northerly right-of-way of Scenic Lane, South 46°42'22" West, a distance of 104.72 feet to a point on the easterly line of Athens-Hocking Landfill, Inc. tract as recorded in Official Record 614 at Page 227, said point bears North 44°10'25" West, a distance of 2.99 feet from a 5/8" rebar with Id. cap stamped "PS-7581" found:

Thence along the easterly lines of Athens-Hocking Landfill, Inc., the following three (3) courses;

North 44°10'25" West, a distance of 105.01 feet to a 5/8" rebar with Id. cap stamped "PS-7581" found;

North 30°07'17" West, a distance of 66.50 feet to a 5/8" rebar with no cap found, passing a 5/8" rebar with no cap found at a distance of 58.33 feet;

North 44°27'42" East, a distance of 83.86 feet to a 5/8" rebar with no cap found at a westerly corner of Fearns' tract;

Thence along the westerly line of Fearn's tract, North 82°18'54" East, a distance of 47.31 feet to the true point of beginning.

Containing 0.464 total acres, being

0.344 acres being part of Tract 1 and all of Auditor's Parcel #P010010060900, 0.080 acres being part of Tract 1 and all of Auditor's Parcel #P010010061000 &

0.040 acres being all of Tract 2 and all of Auditor's Parcel #P010010061701.
