Commencing at a found stone at the northeast corner of River Lot 619, said stone is on the east line of Section 4, York Township and the west line of Section 34, Dover Township; thence on an assumed bearing along the east line of said Section 4 North 04°00'00" East 1,826.69 feet to a found stone at the northeast corner of River Lot 623; thence along the north line of River Lot 623 North 86°00'00" West (passing a set iron pin at 7,068.26 feet) for a total distance of 7,154.21 feet to a set iron pin on the westerly right of way of State Route 33, said set iron pin is THE TRUE POINT OF BEGINNING and is 160.57 feet right of centerline Station 322+34.74 of a centerline survey made in 1963 by the Ohio Department of Highways for the relocation of State Route 33; thence along the west right of way line of State Route 33 South 24°05'04" East 465.30 feet to a point; thence North 82°04'13" West 134.63 feet to point; thence South 23°24'00" East 70.00 feet to a point; thence South 75°17'17" East 162.04 feet to a point; thence South 30°31'33" East 100.77 feet to a point; thence South 22°33'31" East 680.07 feet to a point; thence South 53°58'59" West 343.32 feet to a point; thence South 33° 42' 05" East 55.90 feet to a point; thence North 54°26'49" East 332.46 feet to a point; thence South 23°23'54" East 1,728.41 feet to a set iron pin on the south line of River Lot 618 and on the westerly right of way of State Route 33, said set iron pin is also 140.00 feet right of centerline Station 353+68.14 of aforementioned centerline survey; thence leaving the said westerly right of way of State Route 33 and along the south line of River Lot 618 North 86°30'00" West (passing a set iron pin at 629.73 feet) for a total distance of 763.48 feet to a point in the center of the existing Hocking River; thence along the center of said Hocking River North 27°44'52" West 155.18 feet to a point: thence North 32°36'36" West 150.19 feet to a point; thence North 20°15'07" West 194.55 feet to a point; thence leaving the center

of the Hocking River North 87°22'25" West 27.56 feet to a point on the east right of way line of the Chesapeake and Ohio Railroad; thence following said railroad right of way North 08°09'28" West 520.80 feet to a point; thence along a tangential curve concave to the west 352.33 feet to a point, said curve has a central angle of 10°34'12", a radius of 1909.859 feet and a chord which bears North 12°17'04" West 351.83 feet; thence North 77°42'54" East 13.00 feet to a point; thence North 11°32'58" West 82.50 feet; thence North 23°08'19" West 292.13 feet to a point; thence along a tangential curve concave to the east 275.03 feet to a point, said curve has a central angle of 08°15', a radius of 1910.08 feet and a long chord which bears North 01° 43'34" West 274.79 feet; thence South 57°00'38" West 151.47 feet to a point; thence leaving the easterly right of way line of the Chesapeake and Ohio Railroad and along the Old River Channel North 25°46'44" West 293.70 feet to a point; thence North 33°13'24" West 436.26 feet to a point; thence North 18°09'09" West 232.30 feet; thence North 13°27'29" West 168.19 feet to a point on the north line of River Lot 623; thence leaving said old River Lot Channel and along the north line of River Lot 623 South 86°00'00" East 629.28 feet to the point of beginning containing 41.8310 acres and being part of three tracts described in Volume 340 Page 877 of the Athens County Deed Records. There being approximately 14.9 acres out of tract 1, 17.00 acres out of tract 2 and 9.93 acres out of tract 3. The above described 41.8310 acres is further divided into River Lots, there being approximately 7.8 acres in River Lot 618, 9.0 acres in River Lot 619, 6.38 acres in River Lot 620, 5.28 acres in River Lot 621, 6.63 acres in River Lot 622 and 6.74 acres in River Lot 623. The above described 41.8310 acres is further divided by sections as being approximately 14.90 acres in Section 9 and 26.93 acres in Section 10.

Note: All set iron pins are capped, 5/8 inch diameter rebar, 30 inches in length.
