

Commencing at an iron bolt found in the Northeast corner of F.L. 2 (Section 17) and the Grantor's Northeast property corner of said 70.70 acre tract referred to herein, said iron bolt found also being the real point of

beginning of the tract herein described:

Thence S 04°27'49" W along the East line of said F.L. 2 (Section 17) and the Grantor's East line of said 70.70 acre tract, 1,507.74 feet to an iron pin set; thence N 85°21'41" W along a random line, 688.66 feet to a railroad spike set in the centerline of Alexander Township Road No. 55, passing through iron pins set at: 148.15 feet, 474.16 feet and 670.51 feet; thence the following courses and distances along the said centerline of Alexander Township Road No. 55:
