KNOW ALL MEN BY THESE PRESENTS: that

WHEREAS, in connection with the construction of United States Route 50, Sections 4.95 and 14.18; United States Route 33, Section 16.30 (16.17), Athens County, Ohio, it was necessary for public convenience and welfare for the State of Ohio to acquire certain land within the corporation limits of the City of Athens, Athens County, Ohio, for relocating, connecting streets and roads, and a turnaround, and

WHEREAS, the State of Ohio acquired by Warranty Deed/Easement(s) certain land for construction of portions of the following streets and roads located within the City of Athens, Ohio thereof:

HICKORY STREET, HOOPER STREET, MULLIGAN ROAD, CURTIS STREET AND 'ASTINGS ROAD

City of Athens, Lease Lots 40 and 42 of the Ohio Company Purchase, Town 9 North, Range 14 West,

TRACT 1 - (RELOCATED) HICKORY STREET

located <u>right</u> of United States Routes 33/50 Centerline Survey Station 652 plus 48 thru Station 654 plus 30

TRACT 2 - (RELOCATED) HOOPER STREFT

WHER LS, on August 30, 1978, the City of Athens, Athens County,
Ohio agreed with the State of Ohio, that the aforementioned portions of
streets and roads have been constructed in a satisfactory manner and are
in good repair, and

WHEREAS, on August 30, 1978, the City of Athens, Athens County, Ohio, accepted the aforementioned portions of streets and roads for maintenance and continued public use, and further agreed to maintain the existing pavement(s) inside the limited access right of way up to the bridge(s), and

WHEREAS, in conformity with Federal requirements of Federal Aid Highway Program Manual, Volume 6, Chapter 1, Section 1, Subsection 8, the Federal Highway Administration by letter dated September 28, 1979, on file in the Ohio Department of Transportation, Columbus, Ohio, concurred in the State's proposed transfer of control (relinquishment) of the aforementioned streets and roads to the City of Athens, Ohio;

NOW THEREFORE, the State of Ohio, by David L. Weir, Director of Transportation, and pursuant to the provisions of Section 5501.45 of the Ohio Revised Code, having determined and declared by Entry made on October 17, 1979, in the Real Estate Administration Section of the Journal of the Director of Transportation, Volume 8, Page 385 and for and in consideration of said Agreements by the City of Athens, Athens County, Ohio to accept the aforementioned portions of streets and roads for maintenance and continued public roadway use, does hereby release and forever Quitclaim unto the City of Athens, Athens County, Ohio, all rights, title and interest the State of Ohio may have in and over the following described Real Estate:
