## A CONTINUOUS AND CONTIGUOUS TRANSFER BETWEEN ADJOINERS Tract A

Situated in Section 7, Lee Township, Town 10, Range 15, Athens County, Ohio and described as follows:

Commencing at the estimated northwest corner of the northeast quarter of Section 7, Lee Township, at the northwest corner of a 1.87 acre tract described in Volume 303 Page 64 of the Athens County Deed Records; thence on an assumed bearing along the estimated north line of said Section 7 and the north line of said 1.87 acre tract and the north line of a 6.854 acre tract described in Volume 296 Page 1100 of the Athens County Official Deed Records South 86 Degrees 14 Minutes 24 Seconds East a distance of 751.67 feet to a set iron pin at the northeast corner of said 6.854 acre tract and at the grantor's northwest corner, THE TRUE POINT OF BEGINNING; thence continuing along the estimated north line of Section 7 and along the grantor's north line South 86 Degrees 14 Minutes 24 Seconds East a distance of 337.17 feet to a set iron pin; thence along a new line South 69 Degrees 04 Minutes 09 Seconds West, passing a set iron pin at 405.79 feet, for a total distance of 584.20 feet to a set iron pin on the east line of aforesaid 6.854 acre tract on the grantor's west line; thence along the east line of said 6.854 acre tract and along the grantor's west line the following three bearings and distances: 1) North 48 Degrees 26 Minutes 31 Seconds East a distance of 111.64 feet to an iron pin\*; thence 2) North 44 Degrees 58 Minutes 54 Seconds East a distance of 82.15 feet to an iron pin\*; thence 3) North 34 Degrees 25 Minutes 23 Seconds East a distance of 119.58 feet to the POINT OF BEGINNING and containing 0.880 acres and being a part of a 164.95 acre tract described in Volume 204 Page 707 of the Athens County Official Deed Records.
