

Situated in River Lots 618, 619, 620, 621, 622 and 623 in Section 9, 10, 3 and 4 of Town 12, Range 15, York Township, Athens County, Ohio and described as follows:

Commencing at a found cross marked stone at the northeast corner of River Lot 623 on the east line of Section 4, said east line is also the east line of York Township and the west line of Dover Township; thence along said Township line on an assumed bearing South 04°00'00" West 1,826.69 feet to a found stone on the northeast corner of River Lot 619; thence continuing along the aforementioned Township line South 03°30'00" West 896.28 feet to a point at a fence corner intersection, said point is the southeast corner of River Lot 618; thence along the south line of said River Lot 618 North 86°30'00" West 4.909.17 feet to a point in the center of Monday Creek (witness a set iron pin North 86°30'00" 50.10 feet), said point is THE TRUE POINT OF BEGINNING; thence North 46°48'39" East 221.55 feet to a point in the center of said Monday Creek; thence continuing along said Monday Creek North 33°33'39" East 246.00 feet to a point; thence North 26°03'39" East 307.00 feet to a point; thence North 13°18'39" East 49.59 feet to a point on the westerly right of way line of old State Route 33; thence along said westerly right of way North 28°00'18" West 1,420.75 feet to a point; thence continuing along said westerly right of way on a tangential curve concave to the west 428.795 feet to a point, said curve has a radius of 2,339.7036 feet a central angle of 10°30'02" and a long chord which bears North 33°15'19" West 428.20 feet to a point; thence continuing along the west right of way line of old State Route 33 North 38°30'20" West 9.67 feet to a point at the southeast corner of a 1.00 acre tract described in Volume 322 Page 637 of the Athens County Deed Records; thence along the south side of said 1.00 acre tract and the south side of a 1.5555 acre tract owned by the York Township Trustees and described in Volume 384 Page 449 of the Athens County Deed Records South 51°18'54" West (passing a found iron pin at 293.83 feet) for a total distance of 501.83 feet to a set iron pin; thence North 38°41'06" West 308.68 feet to a set iron pin on the southerly property line of a 6.63 acre tract described in Volume 297 Page 458 of the Athens County Deed Records; thence along said southerly property line South 51°26'38" West 425.58 feet to a point 78.49 feet
