PETITION-ORDINANCE AND RESOLUTION.

TO THE COMMISSIONERS, ATHENS COUNTY, OHIO.....

PETITION FOR DETACHMENT OF LAND FROM THE INCORPORATED VILLAGE OF ALBANY, STATE OF OHIO.

We, the undersigned, being a majority of the free-hold electors owning lands within the following described territory, situate in the Village of Albany, County of Athens and State of Ohio, to-wit:

Beginning at the northeast corner of Sec. 8, Lee Township, Athens County, Ohio; thence south along said section line to the southeast corner of Section 8; thence west along the south line of Section 8 to the southwest corner of the southeast quarter thereof; thence north along the middle line of said section 8 to the southwest corner of Fraction 3; thence north along the west line of said Fraction 3 to the northwest corner thereof and being on the south line of Fraction 12; thence west on said south line to the southwest corner of said Fraction 12; thence north along the west line of Fraction 12 to the northwest corner thereof; thence east along the north line of Fraction 12 to the northeast corner thereof located on the west line of Section 4; thence south along said west line of Section 4 to the southwest corner of the same; thence east on the south line of Section 4 to the northeast corner of Sec. 3; thence south to the southeast corner of Section 3; thence west along the south line of Section 3 to the northeast corner of Section 8 the place of beginning.

do hereby petition your honorable body to detach said above described territory from said Incorporated Village of Albany and to attach the same to Lee Township, Athens County, Ohio, to which Township said territory is contiguous.

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE GIVING THE ASSENT OF THE COUNCIL OF THE VILLAGE OF ALBANY, STATE OF OHIO, TO THE DETACHMENT OF TERRITORY FROM SAID VILLAGE.

Whereas, a petition has been presented to the Council requesting that certain territory within the limits of the said Village of Albany be detached therefrom.

Be it ordained by the Council of the Village of Albany, State of Ohio.

SECTION 1 - That the Council does hereby assent to the detachment from the Incorporated limits of the Village of Albany, State of Ohio, the following described territory, to-wit:

Beginning at the northeast corner of Sec. 8, Lee Township, Athens County, Ohio, thence south along said section line to the southeast corner of Section 8; thence west along the south line of Section 8 to the southwest corner of the southeast quarter thereof; thence north along the middle line of said section 8 to the southwest corner of Fraction 3; thence north along the west line of said Fraction 3 to the northwest corner thereof and being on the south line of Fraction 12; thence west on said south line to the southwest corner of said Fraction 12; thence north along the west line of Fraction 12 to the northwest corner thereof; thence east along the north line of Fraction 12 to the northeast corner thereof located on the west line of Section 4; thence south along said west line of Section 4 to the southwest corner of the same; thence east on the south line of Section 4 to the northeast corner of Section 3; thence south to the southeast corner of Section 3; thence west along the south line of Section 3 to the northeast corner of Section 8 the place of beginning.

SECTION 11 - This ordinance shall take effect and be in full force from and after the earliest period allowed by law.

RESOLUTION.

Mr. Sawyer offered the following resolution and moved that it be adopted, to-wit:

WHEREAS, there has been presented to the Commissioners of Athens County, Ohio, a petition to detach from the Village of Albany, State of Ohio, the territory described in said petition and which said petition is signed by a majority of the freehold electors holding lands in any portion of said territory of said municipality and

WHEREAS, said petition is accompanied by an accurate plat of said territory to be detached and

WHEREAS, the council of the said Village of Albany have assented to the detachment of said territory from said village by an ordinance duly and legally passed by said council.

Be it resolved by the Board of Commissioners of Athens County, State of Ohio, that the said territory be and the same is hereby detached from said Village of Albany, and it is hereby ordered, adjudged and decreed that said territory be so detached from the said Village of Albany, and that the same be attached to the adjacent township of Lee, in the said County of Athens, State of Ohio.

Mr. Mundew seconded the motion and upon call of yeas and nays Porter, Sawyer and Mundew voted yea.

WHEREUPON the president declared the motion carried and said resolution adopted.
