Commencing at the estimated northwest corner of Lease Lot 5, Alexander Township; thence along the north line of Lease Lot 5 and the south line of Lease Lot 4, North 89 Degrees 55 Minutes 31 Seconds East for a distance of 1027.94 feet to the northwest corner of a 15.211 acre tract described in Volume 219, Page 423, Athens County Official Records; thence continuing along the north line of said Lease Lot 5, the south line of said Lease Lot 4 and the north line of said 15.211 acre tract, North 89 Degrees 55 Minutes 31 Seconds East for a distance of 803.10 feet to an iron pin found at the northeast corner of said 15.211 acre tract and THE TRUE POINT OF BEGINNING of this tract; thence leaving the north line of Lease Lot 5 and the south line of Lease Lot 4, along a boundary agreement line, North 86 Degrees 17 Minutes 30 Seconds East for a distance of 803.56 feet to a 28" white oak with blaze on north side at the northeast corner of this tract; thence South 47 Degrees 33 Minutes 26 Seconds West (passing the south line of Lease Lot 4 and the north line of Lease Lot 5 at 75.57 feet) for a total distance of 925.02 feet to an iron pin found at the southeast corner of said 15.211 acre tract and the south corner of this tract; thence along the east line of said 15.211 acre tract, North 11 Degrees 46 Minutes 19 Seconds West for a distance of 584.57 feet to the POINT OF BEGINNING, containing 5.339 acres of which 4.903 acres are in Lease Lot 5 and 0.436 acre is in Lease Lot 4, and being a part of a 44.01 acre tract described in Volume 278, Page 1064, and a part of a 57.15 acre tract described as 2nd Tract in Volume 12, Page 25, Athens County Official Records.

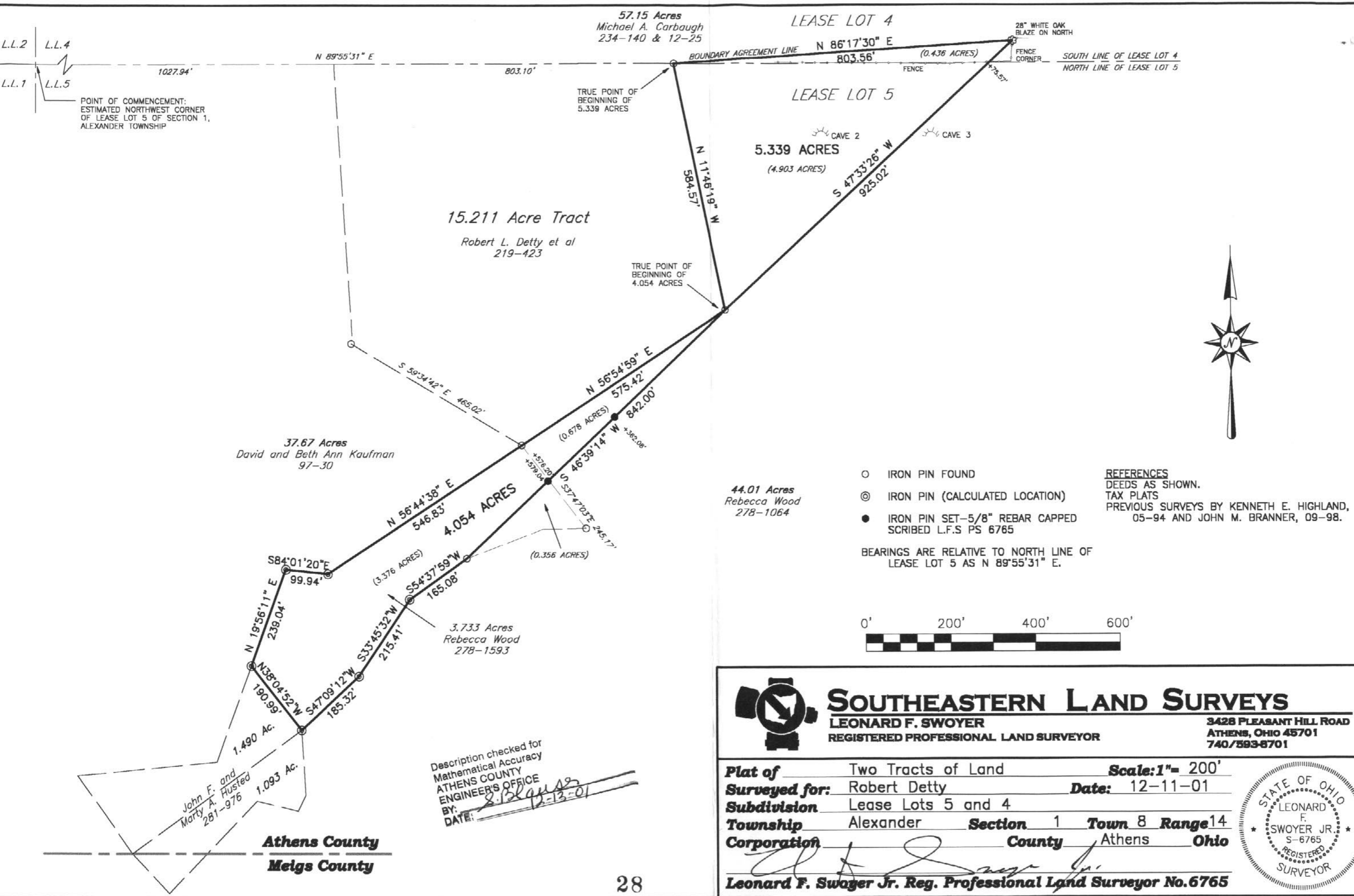
