

DESCRIPTION OF 5.6392 ACRES

Situated in Farm Lot 4, Section 11, Alexander Township, Town 8, Range 14, Athens County Ohio and being more particularly described as follows:

Commencing at a stone in the south line of Farm Lot 4 which is north $86^{\circ} 15'$ west 1664 feet from the southeast corner of said Farm Lot 4; thence north $3^{\circ} 30'$ east 507.90 feet (passing an iron pin at 264.29 feet) to the point of beginning of the tract herein described; thence north $5^{\circ} 43'$ west 135.95 feet to an iron pin found in the center of Township Road 56; thence along the centerline of said road north $2^{\circ} 41' 18''$ east 239.00 feet to an iron pin set; thence north $56^{\circ} 42' 06''$ west 290.98 feet to an iron pin set; thence north $33^{\circ} 37' 48''$ west 203.21 feet to an iron pin set; thence north $50^{\circ} 09' 48''$ west 160.85 feet to an iron pin set; thence north $35^{\circ} 57' 23''$ west 35.10 feet to an iron pin set; thence leaving the road south $86^{\circ} 30' 04''$ east 459.90 feet to an iron pin set, (passing iron pins at 37.00 feet; 193.12 feet; 389.13 feet); thence south $31^{\circ} 12' 36''$ east 752.35 feet to a railroad spike set in the centerline of Twp. Road 56, (passing iron pins at 580.00 feet and 732.35 feet); thence along the centerline of said Twp. Road 56 south $76^{\circ} 54' 41''$ west 100.50 feet to a railroad spike set; thence south $58^{\circ} 47' 24''$ west 114.82 feet to a railroad spike set; thence south $61^{\circ} 50' 18''$ west 170.82 feet to the point of beginning and containing 5.6392 acres.

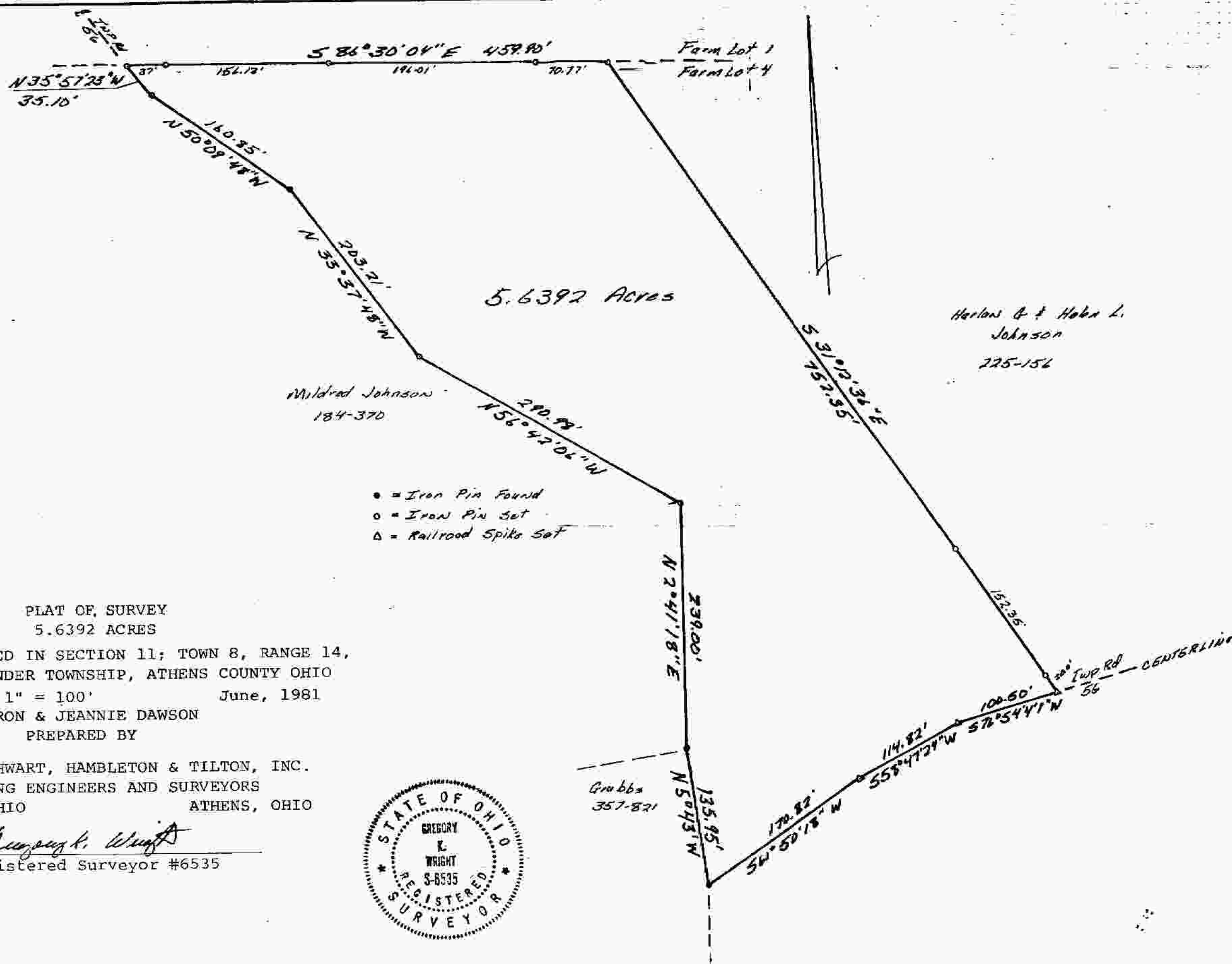
