Situate in F.I. 1, Section 12 and F.L. 1, Section 18, Town 8, Range 14, Alexander Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at the Southeast corner of F.L. 1 (Section 18); thence N 03°50'45" E along the East line of said F.L. 1 (Section 18) and the West line of F.L. 1 (Section 12), 216.91 feet to a point, said point also being the real point of beginning of the tract herein described:

Thence N 20°11'28" W along a random line, 523.25 feet to an iron bar set; thence N 80°38'32" E along a random line, 448.08 feet to a railroad spike set in the Grantor's East line and the existing centerline of Alexander Township Road No. 60 (South Blackburn Road), passing through the East line of F.L. 1 (Section 18) and the West line of F.L. 1 (Section 12) at 218.92 feet and passing through an iron bar set for reference at 428.08 feet, said railroad spike set bearing S 42°24'37" E, 125.00 feet from a railroad spike found in the Southeast corner of a 6.22 acre tract transferred on 2-7-77 to John K. Kellis from Effie A Sabino; thence XXXXXXXXXXX the following courses and distances along said Grantor's East line and the existing centerline of Alexander Township Road No. 60 (South Blackburn Road): S 42°24'37" E, 28.68 feet to a railroad spike set;

S 36°38'37" E, 185.34 feet to a railroad spike set;
S 23°05'47" E, 140.57 feet to a railroad spike set;
S 21°56'22" E, 163.61 feet to an iron bolt found in the
Grantor's Southeasterly corner, said iron bolt found also being in
the Northeasterly corner of a 9.30 acre tract owned by Donald A.
and Joyce E. Smith as recorded in Deed Book 290, Page 609 in the
Athens County Recorder's Office, Athens County, Ohio; thence
S 62°10'46" W along an existing fence line, one of the Grantor's
Southerly lines, and the Northerly line of said 9.30 acre
(D.A. and J.E. Smith) tract, 520.15 feet to an existing fence
post that was set on a surveyed iron pin, said fence post being in
one of the Grantor's Southerly corners; thence N 20°11'28" W along
the Southerly extension of the first course of this description,
138.25 feet to the point of beginning, (making the total distance
of the Westerly line of the herein described tract, 661.50 feet)
and containing a total of 6.6129 acres, of which, 1.2914 acre lies

Subject to all legal highways and easements of record.

in F.L. 1 (Section 18) and 5.3214 acres lie in F.L. 1 (Section 12).

Grantor claims title for the above described tract by Deed Book 336, Page 169 as recorded in the Athens County Recorder's Office, Athens County, Ohio.
