Beginning at a point being the intersection of the centerline of County Road #15 and the West line of Farm Lot No. 1 which bears South 09°37'00" West a distance of 1771.36 feet from an existing wooden post assumed to be the Northwest corner of said Farm Lot No. 1;

Thence leaving said West line and along said centerline the following four courses:

- 1. South 87°15'39" East a distance of 83.50 feet to a point;
- 2. North 64°11'52" East a distance of 66.52 feet to a point;
- North 53°20'46" East a distance of 316.46 feet to a point;
   North 68°24'30" East a distance of 112.07 feet to a point;

Thence leaving said centerline South 09°37'00" West passing thru a 5/8" iron pin set at a distance of 20.00 feet and going a total distance of 736.35 feet to a 5/8" iron pin set;

Thence North 80°47'19" West a distance of 451.72 feet to a stone found on the West line of said Farm Lot No. 1;

Thence along said West line North 09°37'00" East passing thru a 5/8" iron pin set at a distance of 384.25 feet and going a total distance of 404.25 feet to the principal point of beginning containing 5.713 acres± subject to all legal easements and rights-of-way.

Thence leaving said South line North 09°37'00" East passing thru a 5/8" iron pin set at a distance of 855.36 feet and going a total distance of 875.36 feet to a point in the centerline of County Road #15;




