

Description survey for Liz Maule

Being a tract of land transferred to Gail Hecky as recorded in Official Records Volume 412 at Page 1398, Athens County Recorder's Office, Athens County, Ohio, also being a part of Lease Lot 5, Section 35, Township-8, Range-14, Alexander Township, Athens County, State of Ohio, and more particularly described as follows;

Beginning at a 5/8" iron pin set which bears North90°00'00"West, a distance of 1218.57 feet and South00°09'51"West, a distance of 162.62 feet from the northeast corner of said Lease Lot 5, Section 35, T-8, R-14;

Thence along the west line of a tract transferred to David Garrod as recorded in Official records Volume 357 at page 2349 South00°09'51"West, passing thru a 5/8" iron pin set at a distance of 144.57 feet and going a total distance of 164.57 feet to a point in the centerline of Barrows Road;

Thence along said centerline the following two courses;

1. South87°03'47"West, a distance of 208.74 feet to a point;
2. South89°59'59"West, a distance of 55.23 feet to a point;

Thence leaving said centerline and along the boundary of a tract transferred to Floyd Stephen Wolfe as recorded in Official Records Volume 310 at page 251 the following two courses;

1. North00°09'51"East, passing thru a 5/8" iron pin set at a distance of 20.00 feet and going a total distance of 162.60 feet to a 5/8" iron pin set;
2. North87°15'00"East, a distance of 264.00 feet to the principal point of beginning, containing 0.997 acres more or less, subject to all legal easements and rights of way.

Bearings are assumed and for determination of angles only.

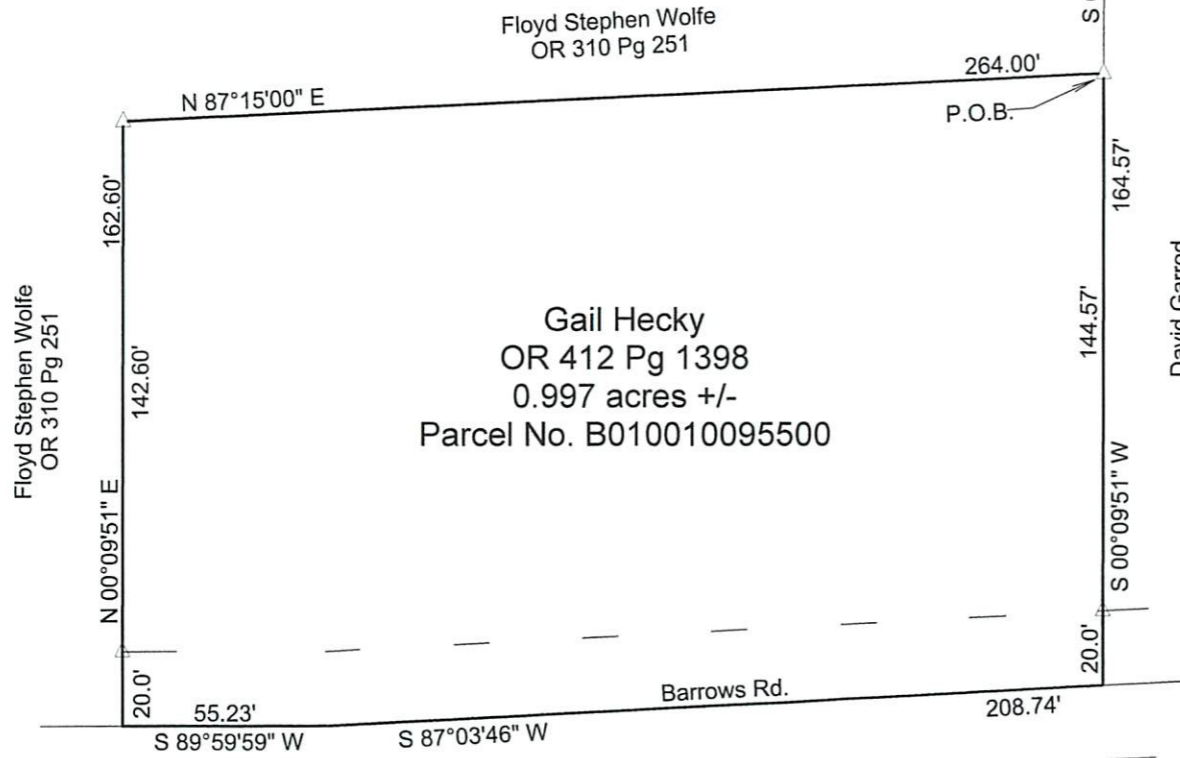

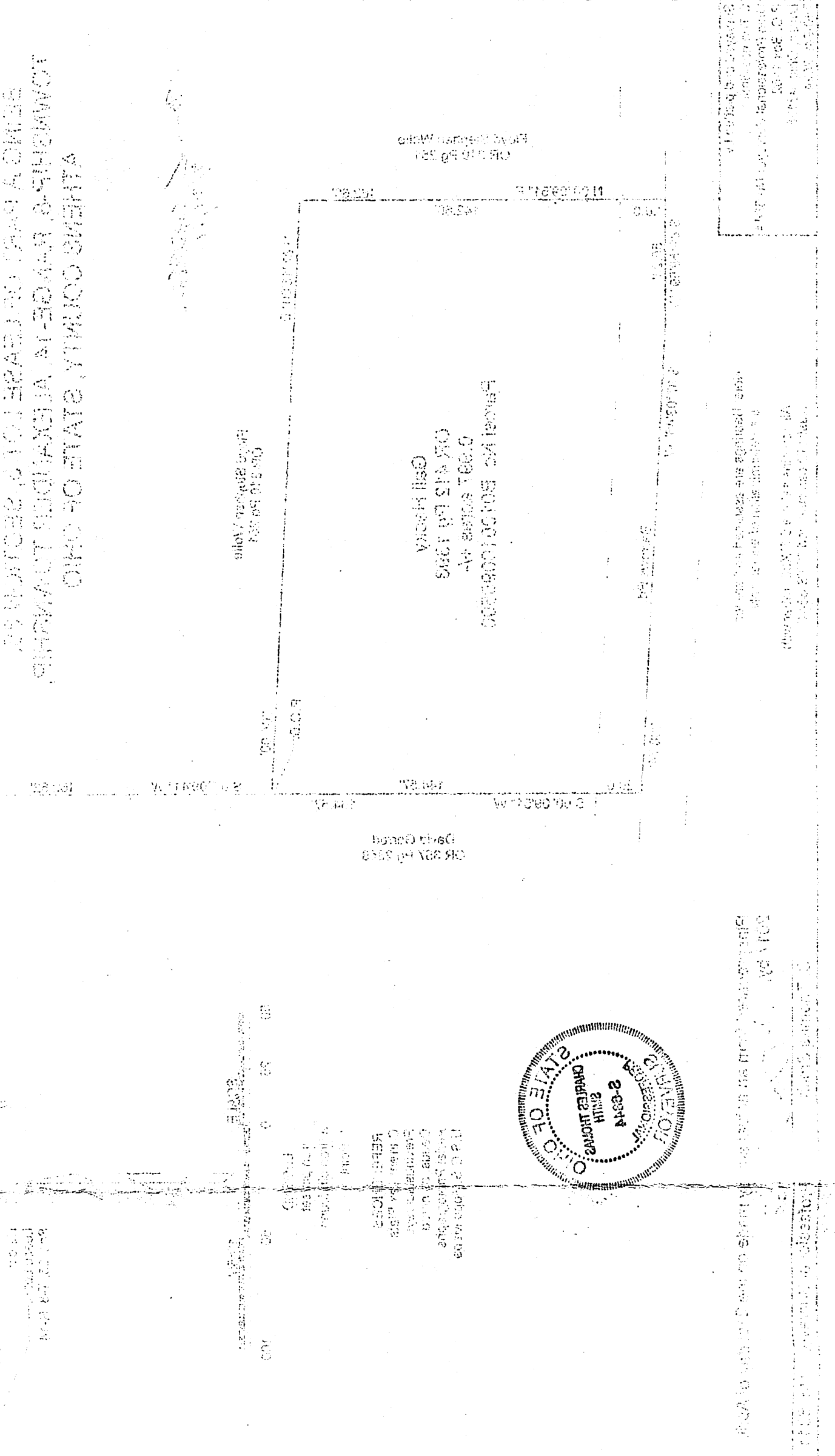

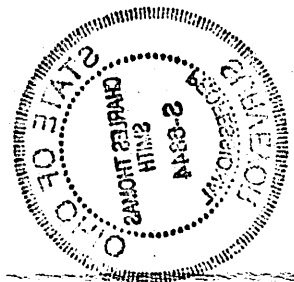
