Commencing at a point marking the Northeast corner of Lot 2 and the Northwest corner of Lot 1, being on the North line of a 61.29 Acre parcel conveyed to Justin M. Smith, as recorded in O.R. Book 47, Page 858, also being on the South line of a parcel conveyed to Amvets Post #93, as recorded in O.R. Book 178, Page 368;

Thence, S 04°06'30" W 367.94 feet with the West line of said Lot 1, also being the East line of said Lot 2 across said parcel conveyed to Smith, to a mag nail set in the centerline of Setty Road marking the Northwest corner of said parcel conveyed to Zion Ventures, LLC, of which this description is a part, and being the <a href="PRINCIPLE PLACE OF BEGINNING">PRINCIPLE PLACE OF BEGINNING</a> of the 22.434 Acre parcel herein to be described;
