Situated in the Township of Alexander, County of Athens, State of Ohio, and being a part of Lease Lot 5 in Section 32, Township 8N, Range 14W, and being more particularly described as follows;

Being a Survey of 2 Parcels conveyed to Martha Dalton, as recorded in O.R. Book 415, Page 2314, in the Athens County Deed Records, and being all of Auditor's P.P.N. B01-00100908-00 & B01-00100910-00, and further described as follows;

Commencing at a 5/8" o.d. iron pin found on the South line of Lease Lot 5, also being the North line of Lease Lot 4 and the Northwest corner of Lot1 of Our Peace Subdivision, as recorded in Plat Envelope 548B, also being the Northeast corner of Lot 4, and being the PRINCIPLE PLACE OF BEGINNING of the 6.831 Acre parcel herein to be described;

Thence, N 86°30'00" W 177.156 feet with the North line of said Lot 4, to an iron pin set at the Southeast corner of a parcel conveyed to Jim R. & Connie Ator, as recorded in O.R. Book 306, Page 2377;

Thence, N 02°22'35" E 343.50 feet with the East line of said parcel conveyed to Ator (OR304Pg2377), to a 5/8" o.d. iron pin found marking the Southeast corner of Lease Lot 2 and a parcel conveyed to Kelly P. Abfall, as recorded in O.R. Book 354, Page 1671;

Thence, N 05°50'50" E 345.83 feet with the East line of Lease Lot 2 and said parcel conveyed to Abfall (OR354,Pg1671), to an iron pin set at the Southwest corner of a 1.23 Acre parcel conveyed to David Tigner, as recorded in O.R. Book 422, Page 1497;

Thence, N 87°51'02" E 309.56 feet with the South line of said parcel conveyed to Tigner (OR422, Pg. 1497), to a point in the centerline of State Route 681, and passing over 5/8" o.d. iron pins found at 189.13 feet and 268.99 feet;

Thence, S 41°38'52" E 124.46 feet with the centerline of State Route 681, to a point marking the Northwest corner of a 0.54 Acre parcel conveyed to Jimmie & Connie Ator, as recorded in O.R. Book 358, Page 845;

Thence leaving State Route 681 with the boundary of said 0.54 Acre parcel conveyed to Ator (OR358,Pg845), with the following three (3) courses and distances:

- S 48°00'40" W 119.02 feet to a 3/4" o.d. iron pin found, and passing over a 3/4" o.d. iron pin found at 31.23 1) feet;
- S 04°03'27" W 110.08 feet to a 5/8" o.d. iron pin found;
- S 85°58'49" E 150.26 feet to a point on the West line of saidLot 1 of Our Peace Subdivision, and passing over a 1" o.d. iron pipe found at 149.60 feet;

Thence with the West and North lines of said Lot 1 of Our Peace Subdivision, with the following two (2) courses and distances:

- S 04°04'43" W 435.37 feet to a 5/8" o.d. iron pin found;
- 5) N 86°30'00" W 287.91 feet to the PRINCIPLE PLACE OF BEGINNING.

Said parcel as surveyed contains 6.831 Acres, more or less, and is subject to all legal easements, right of ways, restrictions, and zoning ordinances of record.
