Situated in the south half of Lease Lot 2 of Section 22, Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a found stone at the northwest corner of Lease Lot 1 of Section 21 of said Alexander Township, said found stone is THE TRUE POINT OF BEGINNING; thence along the north line of Lease Lot 2 of Section 21 and the south line of Lease Lot 2 of Section 22 North 85°48'07" West 384.22 feet to a previously set iron pin at the southeast corner of a 1.8352 acre tract described in Volume 382 Page 244 of the Athens County Deed Records; thence along the east property line of said 1.8352 acre tract North 31°16'25" East 220.84 feet to a previously set iron pin; thence on a random line South 86° 06'21" East 434.64 feet to a set iron pin; thence South 04°41'30" West 200.00 feet to a previously set iron pin on the south line of Lease Lot 2 of afore said Section 22; thence along the south line of said Lease Lot 2 North 85°23' 55" West 149.21 feet to the point of beginning containing 2.1983 acres and being a part of a tract described in Volume 382 Page 243 and 244 of the Athens County Deed Records. The above described tract is to be continuous and contiguous with a 1.8352 acre tract described in Volume 382 Page 244.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


