Situated in Farm Lot 1, Section 25, Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a found five eighth inch rebar at the northwest corner of a 5.00 acre tract described in Volume 59 Page 390 of the Athens County Official Deed Records, said found iron pin is located on an assumed bearing South 28.52 chains, South 89°37'46" East 26.42 chains, and North 03°09'04" East 615.42 feet from the northwest corner of Farm Lot 1, and said found iron pin is THE TRUE POINT OF BEGINNING; thence along a random line the following two bearings and distances:

- 1) North 00°00'00" East 151.69 feet to a set iron pin; thence
- 2) North 62°04'47" East (passing set iron pins at 212.09 feet, 422.60 feet, and 555.46 feet) for a total distance of 583.16 feet to a point in State Route 681; thence along said State Route 681 the following three bearings and distances;
- 1) South 38°12'17" East 117.43 feet to a point; thence
- 2) South 41°54'05" East 204.43 feet to a point; thence
- 3) South 47°35'31" East 125.00 feet to a point at the intersection of State Route 681 with Alexander Township Road 42; thence along Alexander Township Road 42 South 52°08'47" West 164.66 feet to a point; thence leaving said road and along the prolongation of the north line of the remainder of Tract 1 of the Ralph and Gwenda Smith properties described in Volume 334 Page 209 of the Athens County Deed Records North 89°34'51" West (passing a set iron pin\* at 23.66 feet at the northeast corner of said remainder tract) for a total distance of 346.76 feet to a set iron pin\* at the northwest corner of said remainder tract; thence along the west line of said remainder tract South 39°08'59" East 182.80 feet to a found five eighth inch rebar in aforesaid Alexander Township Road 42 at the northeast corner of the aforesaid 5.00 acre tract; thence leaving said road and along the northerly line of said 5.00 acre tract the following three bearings and distances:

1) North 57°08'19" West 20.15 feet to a found five eighth inch rebar;

- 3) North 89°34'51" West 229.89 feet to the point of beginning and containing 5.218 acres and being a part of the first tract of the tracts of land described in Volume 369 Page 523 of the Athens County Deed Records.
- \* denotes iron pin set in comformance to the intent of a survey performed by Gregory K. Wright, Registered Surveyor No.6535, dated July of 1992, which yielded 0.519 acres in a retracement survey of the aforesaid remainder of Tract 1 of the Ralph and Gwenda Smith properties described in Volume 334 Page 209 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch in diameter and 30 inches in length and capped with a plastic identification marker scribed Leonard F. Swoyer R.L.S. 6765.

The area computes to be 5.22 acres.




