Situated in Farm Lot 2 of Section 28, Range 14 West, Town 8 North, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a found lag bolt on the west property line of a 1.25 acre tract described in Volume 259 Page 49 of the Athens County Deed Records, said bolt bears North 03 degrees 20 minutes 02 seconds East 117.51 feet from the southwest corner of said 1.25 acre tract and is on the common line of Farm Lot 1 and Farm Lot 2; thence along said Farm Lot line North 03 degrees 20 minutes 02 seconds East 353.34 feet to a found lag bolt in the center of Alexander Township Road 55; thence along said road South 62 degrees 47 minutes 25 seconds West 50.38 feet to a set railroad spike the southeast corner of the grantor's property and THE TRUE POINT OF BEGINNING; thence along the center of aforementioned road and the north property line of a 20.08 acre tract described by the Laws of Ohio 7-1-63 Volume 130, Senate Bill 363 South 62 degrees 49 minutes 00 seconds West 182.71 feet to a set railroad spike; thence leaving said road North 17 degrees 20 minutes 20 seconds West (passing set iron pins at 17.10 feet and 254.11 feet) for a total distance of 373.68 feet to a set iron pin; thence North 03 degrees 20 minutes 02 seconds East (passing a set iron pin at 168.62 feet) for a total distance of 470.50 feet to a set iron pin on the north line of Farm Lot 2; thence along said north line and the south line of a 15.66 acre tract described in Volume 322 Page 385 of the Athens County Deed Records South 86 degrees 36 minutes 29 seconds East 332.70 feet to a set iron pin, the northeast corner of Farm Lot 2 and the northeast corner of the grantor's property; thence along the common line of Farm Lot 1 and Farm Lot 2 and the west property line of a 9.86 acre tract described in Volume 363 Page 401 of the Athens County Deed Records South 03 degrees 20 minutes 02 seconds West (passing set iron pins at 95.61 feet and 284.83 feet) for a total distance of 473.27 feet to a set iron pin on the north property line of Parcel 3a described in Volume 360 Page 137 of the Athens County Deed Records; thence along said north line South 70 degrees
