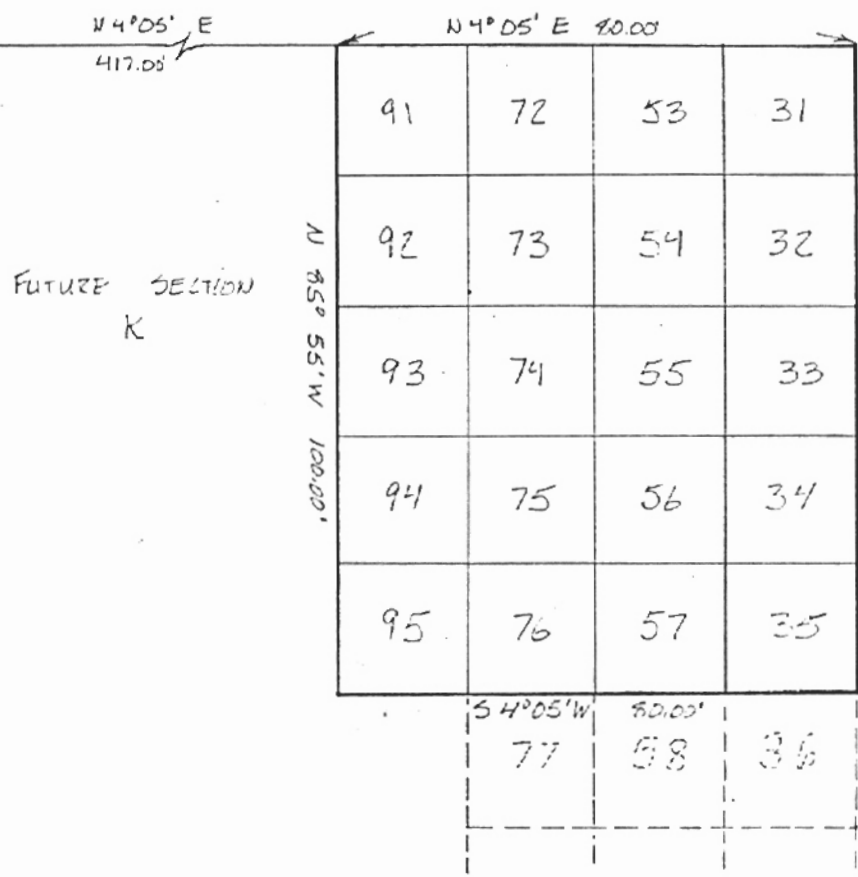
SOUTHWEST CORNER
