Situated in Farm Lot 3 and Farm Lot 5 of Sections 9 and 3 respectively Town 8, Range 14, Alexander Township, Athens County, Ohio and described as follows:

Commencing at a fence post at the southwest corner of Lot 18 in the "Village of Pleasanton" and the southeast corner of a 4.718 acre tract described in Volume 341 Page 181 of the Athens County Deed Records; thence along the south line of said 4.718 acre tract South 63 degrees 56 minutes 44 seconds West a distance of 177.40 feet to a fence post; thence North 88 degrees 07 minutes 01 second West, a distance of 175.55 feet to a point, the southwest corner of said 4.718 acre tract; thence along the west line of the grantor's 10.84 acre tract described in Volume 384 Page 383 of the Athens County Deed Records and the east line of a 76.16 acre tract described in Volume 216 Page 160 of the Athens County Deed Records South 1 degree 10 minutes 54 seconds West, a distance of 473.53 feet to a set iron pin, THE TRUE POINT OF BEGINNING; thence North 78 degrees 42 minutes 11 seconds East, a distance of 320.80 feet to a set iron pin; thence North 27 degrees 03 minutes 56 seconds East, a distance of 357.48 feet to a set iron pin; thence South 86 degrees 09 minutes 43 seconds East, a distance of 162.03 feet to a set iron pin; thence South 6 degrees 24 minutes 24 seconds West, a distance of 112.24 feet to a set iron pin; thence South 30 degrees 04 minutes 33 seconds East, a distance of 99.90 feet to a set iron pin; thence South 85 degrees 17 minutes 49 seconds East, a distance of 185.32 feet to a set iron pin; thence South 58 degrees 32 minutes 16 seconds East (passing a set iron pin at 210.61 feet) for a total distance of 233.37 feet to a point in the center of Athens County Road 21; thence along said road South 4 degrees 12 minutes 02 seconds East, a distance of 17.78 feet to a point, the northeast corner of a 3.00 acre tract described in Volume 227 Page 582 of the Athens County Official Deed Records; thence leaving the said road and along the north property line of said 3.00 acre tract South 89 degrees 17 minutes 17 seconds West (passing found iron pipes at 20.82 feet and 393.13 feet) for a total distance of 450.27 feet to a found pinch pipe, the northwest corner of the said 3.00 acre tract; thence along the west property line of said 3.00 acre tract South 0 degrees 56 minutes 51 seconds West, a distance of 337.14 feet to a found 1 1/2" nine at the southwest

corner of said 3.00 acre tract and the southeast corner of the aforesaid 10.84 acre tract; thence along the south line of the aforesaid grantor's 10.84 acre tract North 87 degrees 56 minutes 40 seconds West, a distance of 612.34 feet to a found stone at the southwest corner of the grantor's 10.84 acre tract; thence along the west property line of the grantor and the east property line of a 76.16 acre tract North 1 degree 10 minutes 54 seconds East, a distance of 303.16 feet to the POINT OF BEGINNING and containing 8.0043 acres, and being 0.07 acres out of a 1.53 acre tract, 1.03 acres out of a 2.66 acre tract and 6.9043 acres out of 10.84 acre tract, said tracts are described in Volume 384 Page 383 of the Athens County Deed Records. The above described tract is also subdivided as being 1.03 acres out of Farm Lot 5 of Section 3 and 6.9743 acres out of Farm Lot 3 Section 9.

Note: Unless otherwise noted all set iron pins are 5/8 inch diameter rebar, 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer P.L.S. 6765. The above description was prepared under the supervision of Leonard F. Swoyer Registered Professional Land Surveyor Number 6765 and based on a field survey performed by Southeastern Land Surveys dated July 4,1998.


