## Legal Description Tract 2: 5.000 Acres part Todd E. Wolfe & Susan Bennett-Wolfe Parcels: O.R. Book 305, Page 1705 & O.R. Book 391, Page 2368

Situated in the Township of Ames, County of Athens, State of Ohio, and being a part of Section 16 & Section 17, Township 6N, Range 13W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of a part of 2 Parcels conveyed to Todd E. Wolfe & Susan Bennett-Wolfe, as recorded in O.R. Book 305, page 1705 & O.R. Book 391, Page 2368, in the Athens County Deed Records, and being part of Auditor's P.P.N. C01-00100302-00 & C01-00100299-04, and further described as follows;

Commencing at a 5/8" o.d. iron pin found marking the Northeast corner of Section 16, also being the Southeast corner of Section 17;

Thence, N 85°17'32" W 1403.47 feet with the North line of Section 16, also being the South line of Section 17, to an iron pin set on the East line of said parcel conveyed to Wolfe (O.R.391,Pg.2368) of which this description is a part, also being on the West line of a 21.935 Acre parcel conveyed to Todd E. Wolfe & Susan Bennett-Wolfe, as recorded in O.R. Book 391, Page 2368, and passing over 5/8" o.d. iron pins found at 199.52 feet and 339.87 feet respectively;

Thence, N 04°57'26" E 185.63 feet with an arbitrary line across said parcel conveyed to Wolfe (O.R.391,Pg.2368) of which this description is a part, to an iron pin set, and being the **PRINCIPLE PLACE OF BEGINNING**, of the **5.000 Acre** parcel herein to be described;


Thence, S 40°04'51" W 647.09 feet across said parcels conveyed to Wolfe (O.R.391,Pg.2368 & O.R.305,Pg.1705) of which this description is a part, to the centerline of Henry Road (Twp. Road 340), passing over the line between Section 16 & Section 17 at 227.65 feet, and passing over an iron pin set at 622.09 feet;

Thence with the centerline of Henry Road, the same being the South line of said parcel conveyed to Wolfe (O.R.305,Pg.1705), with the following three (3) courses and distances:

- 1) N 59°31'35" W 80.99 feet to an angle point;
- 2) N 61°56'41" W 46.11 feet to an angle point;
- 3) N 63°21'49" W 299.27 feet to an angle point;

Thence leaving Henry Road with a line across said parcels conveyed to Wolfe (O.R.305,Pg.1705 & O.R.391,Pg.2368), with the following three (3) courses and distances:

- 4) N 52°54'12" E 98.02 feet to a mag nail set on a wood corner post, and passing over an iron pin set at 25.00 feet;
- 5) N 39°33'30" E 361.96 feet to an iron pin set, and passing over the line between said Section 16 & Section 17 at 135.77 feet;
- 6) S 85°17'38" E 487.58 feet to the PRINCIPLE PLACE OF BEGINNING;
