**Description of a 5.006 Acre Tract**

Situated in Fraction 17, Section 22, T-6, R-13, Ames Township, Athens County, State of Ohio and being a portion of tracts as described in Volume 313, Page 123, and Volume 377, Page 107 of the Deed Records of Athens County and being more particularly described as follows:

BEGINNING at a point in the center of TR-336 that bears South  $36^{\circ}25'57''$  East, 1201.13 feet from the Northwest corner of Fraction 17 (deed),

THENCE leaving said road and along a new line North  $72^{\circ}11'07''$  East, 980.48 feet to a point, (passing iron pins set at 11.77 feet and at 956.48 feet),

THENCE along the line of Toomey (382-449), South  $9^{\circ}59'14''$  East, 374.00 feet to a point in a creek,

THENCE along the line of Baker (191-265 OR), the following three courses:

- 1) North  $89^{\circ}21'27''$  West, 98.07 feet to an iron pin found, (passing an iron pin found at 8.31 feet),
- 2) South  $89^{\circ}37'25''$  West, 758.68 feet to an iron pin found,
- 3) South  $70^{\circ}56'14''$  West, 102.38 feet to a point in the center of TR-336, (passing an iron pin found at 87.67 feet),

THENCE along the center of said road North  $22^{\circ}59'15''$  West, 114.81 feet to the point of beginning and containing 5.006 acres, of which 0.309 acres is out of the tract described in Deed 313-123 (7.11ac.), and 4.697 acres is out of the tract described in Deed 377-107 (16.45 ac.).

Bearings are to an assumed meridian and are for angular determination only

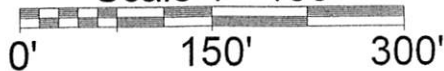
