## DESCRIPTION OF A 3.828 ACRE TRACT

thence, South 89 degrees 24 minutes 36 seconds West, a distance of 1254.07 feet (Deed) to a point in County Road 36;

thence, with said Road, North 2 degrees 45 minutes 29 seconds West, a distance of 469.92 feet (Deed) to a point at the Southwest corner of one of the Grantors West lines, said point being the POINT OF BEGINNING of the following described tract; thence, leaving said Road and following the Grantors West line, North 12 degrees 35 minutes 31 seconds West, a distance of 954.80 feet (Basis of Bearing) to a point in the aforementioned County Road 36, Referenced by an iron pin found Bearing North 12 degrees 50 minutes 40 seconds West, a distance of 35.36 feet, and passing an iron pin set at 100.00 feet, an iron pin found at 693.00 feet and an iron pin set at 914.80 feet:

thence, leaving the grantors West line and following said Road, South 69 degrees 00 minutes 36 seconds East, a distance of 195.56 feet to a point, said point being the point of curvature of a tangent curve, concave to the southwest, having a radius of 297.09 feet and a central angle of 88 degrees 54 minutes 24 seconds, a tangent of 291.47 feet, a chord of 416.11 feet and a chord Bearing, South 24 degrees 33 minutes 23 seconds East;

thence, southeast along said curve, a distance of 460.99 feet to a point;

thence, South 19 degrees 53 minutes 49 seconds West, a distance of 389.49 feet to a point;

thence, South 7 degrees 12 minutes 44 seconds West, a distance of 118.00 feet to the POINT OF BEGINNING; said described tract containing 3.828 acres (166,767.1354 square feet), and is to be continuous and contiguous with a 50.12 acre tract described in volume 295 Page 383 Official Records of Athens County.


