



DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Ames, T-6, R-13, being a part of Sun Vest, Inc. OR 301 Pg. 2358, being part of the East Half of Section 35 & the West Half of Section 29, and more particularly described as follows:

Beginning at an iron pin found at the Northwest Corner of Section 35; thence along the West Line of Section 35 South 00 Degrees 00 Minutes 00 seconds West 184.05 feet to an iron pin found; thence North 88 Degrees 56 Minutes 25 Seconds East 2439.31 feet to a point in the centerline of Twp. Rd. 94, passing an iron pin set at 226.08 feet; thence along said centerline North 47 Degrees 42 Minutes 34 Seconds East 42.36 feet to a point; thence leaving said centerline North 08 Degrees 03 Minutes 05 Seconds West 1799.37 feet to a stone found, passing an iron pin set at 30.00 feet; thence North 68 Degrees 03 Minutes 05 Seconds West 1026.30 feet to an iron pin set; thence South 89 Degrees 25 Minutes 35 Seconds West 464.07 feet to an iron pin set; thence North 04 Degrees 53 Minutes 51 Seconds East

814.58 feet to an iron pin set; thence South 69 Degrees 58 Minutes 11 Seconds West 236.30 feet to an iron pin set; thence North 02 Degrees 41 Minutes 20 Seconds West 739.39 feet to a point in the centerline of Twp. rd. 334, passing an iron pin set at 726.65 feet; thence along said centerline the next 7 courses to points: North 81 Degrees 32 Minutes 43 Seconds East 136.22 feet; thence North 62 Degrees 56 Minutes 40 Seconds East 55.52 feet; thence North 28 Degrees 36 Minutes 33 Seconds East 69.09 feet; thence North 00 Degrees 55 Minutes 34 Seconds East 61.21 feet; thence North 20 Degrees 25 Minutes 14 Seconds West 136.45 feet; thence North 38 Degrees 18 Minutes 18 Seconds West 214.75 feet; thence North 30 Degrees 59 Minutes 07 Seconds West 32.94 feet to the place of beginning, containing 157.27 acres total, being 128.79 acres in Section 35 & 28.48 acres in Section 29, more or less, subject to all legal highways and easements.
