Commencing at a stone in the Southeast corner of Section 4; thence N 54°59'00" W along the South line of said Sect. 4, 2,810.21 feet to an iron pin; thence N 05°15'00" E along a line, 598.75 feet to a point; thence S 04°45'00" E along a line, 7.32 feet to an iron bar set in the existing centerline of Athens County Road No. 41, said iron bar also being the real point of beginning of the parcel herein described:

Thence the following courses and distances along said existing centerline of said Ath. Co. Rd. No. 41;

N 18°56'23" E, 219.11 feet to an iron bar set;

N 20°47'05" E, 83.09 feet to an iron bar set;

N 29°03'30" E, 115.63 feet to a P.K. nail and cap set; thence S 44°12'18" E along a line, 157.40 feet to a 1 $\frac{1}{4}$ " iron pipe set, passing through a 1" iron pipe set at 24.65 feet; thence S 41°43'18" W along a line, 371.05 feet to a 1" iron pipe set; thence N 79°04'46" W along a line, 19.93 feet to the P.C.B. and containing 0.8358 acres.


