Situated in the Township of Ames, County of Athens, State of Ohio, and being a part of the North Half of Section 30, Township 6N, Range 13W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of a parcel conveyed to Carolyn J. Beasley, as recorded in O.R. Book 514, Page 2343, in the Athens County Deed Records, also being all of Auditor's P.P.N. C03-00200001-00, and further described as follows;

Commencing at an iron pin set marking the Northwest corner of Section 30 of Ames Township, Athens County, also being the Northeast corner of Section 36 and a 32.69 Acre parcel conveyed to Andrew J. Studniarz, as recorded in O.R. Book 459, Page 1598, being on the South line of Homer Township, Morgan County, and being the **PRINCIPLE PLACE OF BEGINNING** of the **118.085** Acre parcel herein to be described;

Thence, S 86°22'30" E 469.75 feet with the North line of Section 30 of Ames Township, Athens County, the same being the South line of Section 25 of Homer Township, Morgan County, to a 5/8" o.d. iron pin found marking the Northwest corner of an 8.128 Acre parcel conveyed to Joseph A. Wolfe, ETAL, as recorded in O.R. Book 272, Page 604;

Thence leaving said County Line with the boundary of said 8.128 Acre parcel conveyed to Wolfe, ETAL (OR272,Pg604), with the following five (5) courses and distances:



- 4) S 86°22'30" E 408.12 feet to the centerline of Hooper Ridge Road (Co. Road 36), and passing over a 5/8" o.d. iron pin found at 368.12 feet;

Thence with the centerline of Hooper Ridge Road, with the following thirteen (13) courses and distances:

- 5) S 35°05'49" E 85.12 feet to an angle point;
- 6) S 29°12'18" E 141.94 feet to a point of curvature;
- 7) With a curve to the left (Radius 331.64 feet, Delta Angle 52°19'46", Arc Length 302.89 feet) with a chord bearing S 55°22'11" E 292.48 feet to a point of tangency;
- 8) S 81°32'04" E 184.44 feet to a point of curvature;
- 9) With a curve to the right (Radius 385.75 feet, Delta Angle 28°34'14", Arc Length 192.35 feet) with a chord bearing S 67°14'57" E 190.37 feet to a point of tangency;
- 10) S 52°57'50" E 131.15 feet to a railroad spike set at the centerline intersection of Hooper Ridge Road and Robinson Road (Co. Road 99);
- 11) S 49°35'22" E 166.06 feet to a point of curvature;
- 12) With a curve to the right (Radius 754.00 feet, Delta Angle 52°35'17", Arc Length 692.05 feet) with a chord bearing S 23°17'43" E 668.01 feet to a point of tangency;

- 14) S 10°43'43" W 34.70 feet to a railroad spike set at the centerline intersection of Hooper Ridge Road and W. Kaslar Creek Road (Co. Road 37);

- 24) With a curve to the left (Radius 100.00 feet, Delta Angle 63°53'49", Arc Length 111.52 feet) with a chord bearing S 68°17'05" W 105.83 feet to a point of tangency;
- 25) S 36°20'10" W 240.43 feet to a point of curvature;
- 26) With a curve to the right (Radius 150.00 feet, Delta Angle 53°20'10", Arc Length 139.63 feet) with a chord bearing S 63°00'15" W 134.65 feet to a point of tangency;
- 27) S 89°40'20" W 182.02 feet to an angle point;
- 28) S 86°44'23" W 220.33 feet to a point of curvature;
- 29) With a curve to the left (Radius 114.13 feet, Delta Angle 60°16'15", Arc Length 120.06 feet) with a chord bearing S 56°36'15" W 114.60 feet to a point of tangency;
- 30) S 26°28'08" W 46.77 feet to a point of curvature;
- 31) With a curve to the right (Radius 84.75 feet, Delta Angle 89°38'37", Arc Length 132.60 feet) with a chord bearing S 66°17'57" W 119.48 feet to a point of reverse curvature;
- 32) With a curve to the left (Radius 219.82 feet, Delta Angle 20°04'03", Arc Length 76.99 feet) with a chord bearing N 75°56'13" W 76.60 feet to a point of tangency;
- 33) N 88°52'18" W 383.49 feet to the Southeast corner of a 74.30 Acre parcel conveyed to Andrew J. Studniarz, as recorded in O.R. Book 544, Page 2435, and being on the West line of Section 30;

Thence, N 03°27'04" E 2668.95 feet leaving Concord Church Road with the West line of Section 30, the same being the East line of Section 36 and said 74.30 Acre parcel conveyed to Studniarz (OR544,Pg.2435) and extending along the East line of said 32.69 Acre parcel conveyed to Studniarz (OR459, Pg. 1598), to the PRINCIPLE PLACE OF BEGINNING, passing over an iron pin set at 30.00 feet, and containing 118.085 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The bearings of the above description are based on the North line of Section 30 of Ames Township, Athens County, Ohio, as being S 86°22'30" E, and is based on the O.D.O.T. CORS Network System South Zone.

All iron pins set are 5/8" o.d. reinforcing bars 30" long with red caps labeled "S.A. ENGLAND #7452".
