Thence from this Point-of-Beginning S26°44'49" E 233.06 feet to an iron pin set;

Thence S 03°11'11" W 200.00 fet to an iron pin set;

Thence S 25°30'55" E 404.48 feet to an iron pin set in the north right of way line of the State of Ohio as described in Deed Records Vol. 332 Page 705;

Thence continuing along said right of way line N 52°59'04" E 182.66 feet to an iron pin set;

PLAT of SURVEY

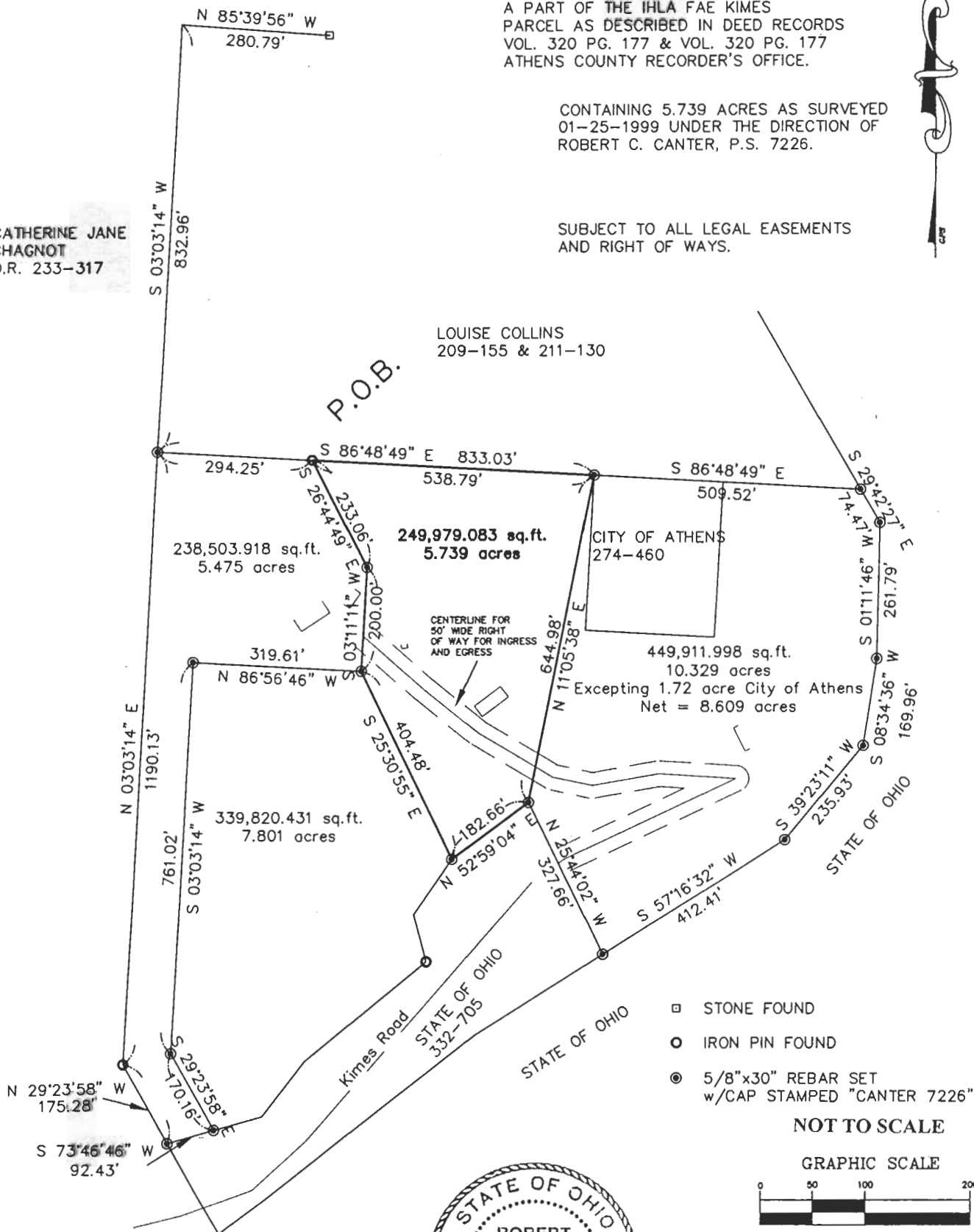

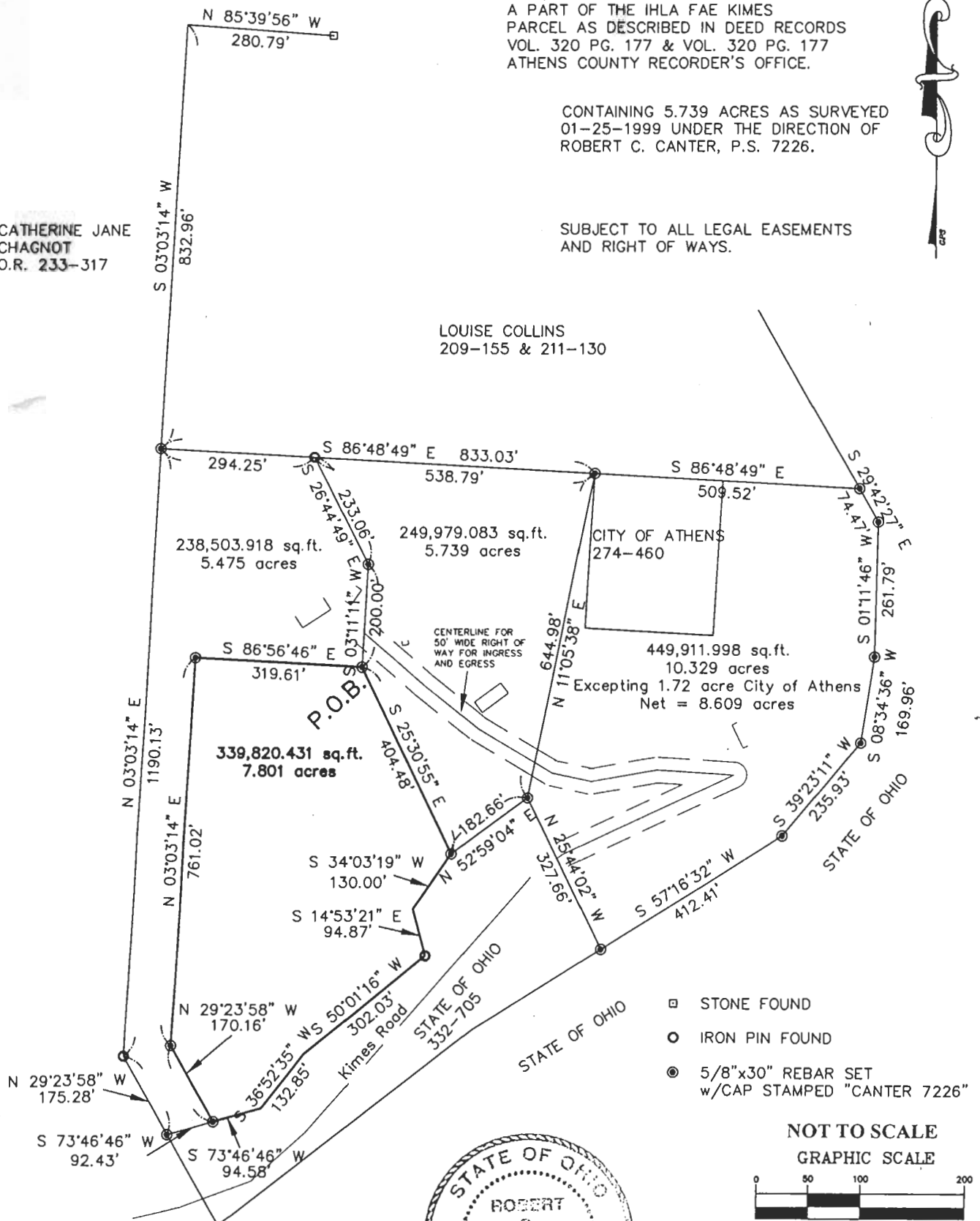

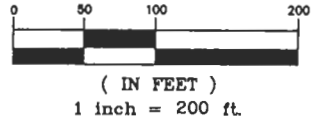
