DESCRIPTION LEGAL 3.204 ACRES

Situate in the City of Athens, Athens County, Ohio. Being part of Outlots 47 and 48 and being part of a 7.74 acre tract conveyed to Athens Gardens, Ltd., recorded in Deed Book 362, Page 117 of the Athens County Recorder's Office, being particularly described as follows:

Beginning at an iron pipe found on a westerly line of the Athens Gardens, Ltd. tract, said pipe being South 85 degrees 25 minutes 38 seconds East for a distance of 93.09 feet to a 3/4" iron pipe found; and North 10 degrees 22 minutes 00 seconds East for a distance of 40.22 feet from a stone found at the southwest corner of Outlot 48;

THENCE North 10 degrees 22 minutes 00 seconds East for a distance of 239.85 feet to a point;
THENCE North 24 degrees 30 minutes 00 seconds East for a

distance of 146.93 feet to a point;

THENCE North 33 degrees 05 minutes 00 seconds East for a

distance of 145.77 feet to a point;
THENCE North 42 degrees 16 minutes 00 seconds East for a distance of 145.98 feet to a point;

THENCE South 85 degrees 30 minutes 00 seconds East for a distance of 60.54 feet to the northwest corner of a 0.76 acre tract conveyed to Columbus & Southern Ohio Electric Company (Deed Book 226, Page 143);

THENCE South 03 degrees 38 minutes 00 seconds West along the west line of said 0.76 acre tract for a distance of 330.00 feet to a point;

THENCE South 04 degrees 02 minutes 00 seconds West continuing along said west line for a distance of 290.11 feet to a point;

THENCE North 85 degrees 30 minutes 00 seconds West through the Athens Gardens, Ltd. 7.74 acre tract for a distance of 301.81 feet to the Point of Beginning.

LEGAL DESCRIPTION 30' WIDE INGRESS-EGRESS EASEMENT

Situate in the City of Athens, Athens County, Ohio. Being an ingress-egress easement 30 feet in width which is part of Outlot 60 and being part of a 7.74 acre tract conveyed to Athens Gardens, Ltd., recorded in Deed Book 362, Page 117 of the Athens County Recorder's Office, being more particularly described as follows:

The centerline of said 30 foot easement (15 feet each side) begins at a point on the northerly right-of-way line of West State Street and on the southerly line of the Athens Gardens, Ltd. tract, said point being South 86 degrees 25 minutes 00 seconds East for a distance of 15.08 feet from the southwesterly corner of said tract;

THENCE North 02 degrees 25 minutes 15 seconds West for a distance of 18.16 feet to a point of curvature;

THENCE along a curve to the left having a radius of 85.00 feet and an arc length of 84.24 feet, being subtended by a chord of North 30 degrees 48 minutes 49 seconds West for a distance of 80.84 feet to a point of tangency;

THENCE North 59 degrees 12 minutes 22 seconds West for a

distance of 110.72 feet to a point of curvature;

THENCE along a curve to the right having a radius of 109.00 feet and an arc length of 63.57 feet, being subtended by a chord of North 42 degrees 29 minutes 59 seconds West for a distance of 62.67 feet to a point of tangency;

THENCE North 25 degrees 47 minutes 35 seconds West for a distance of 288.09 feet to a point which is perpendicularly 15 feet from a westerly line of said tract;

THENCE North 07 degrees 25 minutes 00 seconds West along a

line parallel to and 15 feet measured perpendicularly from said west line for a distance of 244.58 feet to a point;

THENCE North 10 degrees 22 minutes 00 seconds East for a distance of 39.41 feet to the terminus of this easement on the northerly line of Phase I of Athens Gardens, Ltd., said point being South 85 degrees 30 minutes 00 seconds East a distance of 15.08 feet from a 3/4" iron pipe found at the northwest corner of Phase I.




