

- Course No. 6: Thence, N 87° 59' 55" W, with a line of said 3.325 acre parcel and the Northerly line of said 0.851 acre parcel, 135.00 feet to an iron pin (found CTS), being a corner of said 3.325 acre parcel, the northwesterly corner of said 0.851 acre parcel and a point in the easterly line of a 6.22 acre parcel as conveyed to Athens Shopping Plaza LLC by a deed recorded in Official Records Book 110 at Page 398 of the Athens County Deed Records;
- Course No. 7: Thence, N 00° 28' 23" W, with a line of said 3.325 acre parcel and the easterly line of said 6.22 acre parcel, 158.52 feet to an iron pin (found Snyder), being a corner of said 3.325 acre parcel, the northeasterly corner of said 6.22 acre parcel and a corner of said 8.10 acre parcel;
- Course No. 8: Thence, N 87° 36' 51" W, with a line of said 8.10 acre parcel and the northerly line of said 6.22 acre parcel, 269.53 feet to an iron pin (found Snyder);

- Course No. 9: Thence, N 25° 35' 06" E, with a line through said 8.10 acre parcel, 212.71 feet to an iron pin (found Snyder);
- Course No. 10: Thence, S 87° 36' 51" E, with a line through said 8.10 acre parcel, 176.06 feet to an iron pin (found Snyder), being a point in the westerly line of said 3.325 acre parcel and on a line of said 8.10 acre parcel;
- Course No. 11: Thence, N 00° 28' 23" W, with said line, 62.30 feet to an iron pin (found CTS), being a corner of said 8.10 acre parcel and the northwesterly corner of said 3.325 acre parcel;
- Course No. 12: Thence, S 87° 57' 17" E, with a line of said 8.10 acre parcel and the northerly line of said 3.325 acre parcel, 315.00 feet to the **Point of Beginning**, containing **4.325 acres**, more or less, being subject to all legal right of ways, easements, reservations and restrictions of record.
