Situated in Tract 11 of Allen's Bungalow Addition, Section 8, Town 9, Range 14, Athens City, Athens Township, Athens County, Ohio and described as follows:

Commencing at an iron pin set on the north right of way line of Mulligan Road at the southeast corner of Tract 11 of Allens Bungalow Addition and at the southeast corner of a 2.94 acre tract described in Volume 208 Page 521 of the Athens County Deed Records; thence on an assumed bearing along the north right of way line of said road North 73 degrees 14 minutes 55 seconds West, passing a set iron pin at 70.00 feet, for a total distance of 153.00 feet to a point at the southeast corner of a 0.90 acre tract described in Volume 306 Page 507 of the Athens County Deed Records, said point is witnessed by a found, bent iron pin which bears South 55 degrees 29 minutes 14 seconds West 1.13 feet and said point is THE TRUE POINT OF BEGINNING; thence continuing along said north right of way line, the following three bearings and distances: North 73 degrees 14 minutes 55 seconds West, a distance of 15.00 feet to a point witnessed by a found, bent iron pin which bears South 29 degrees 20 minutes 22 seconds West 1.15 feet; thence South 88 degrees 40 minutes 51 seconds West, a distance of 131.00 feet to an iron pin found; thence North 76 degrees 41 minutes 00 seconds West, a distance of 78.00 feet to a point at the southwest corner of said 0.90 acre tract and at the southeast corner of a 0.69 acre tract described in Volume 267 Page 389 of the Athens County Deed Records ; thence along the west line of said 0.90 acre tract and along the west line of the aforesaid 2.94 acre tract North 16 degrees 47 minutes 00 seconds East, a distance of 525.00 feet to a point at the northwest corner of said 2.94 acre tract and at the northeast corner of a 0.49 acre tract described in Volume 385 Page 117 ; thence along the north line of said 2.94 acre tract South 72 degrees 11 minutes 00 seconds East, a distance of 229.25 feet to a set iron pin; thence along a random line the following three bearings and distances: South 24 degrees 56 minutes 07 seconds West, a distance of 279.77 feet to an iron pin set; thence South 41 degrees 12 minutes 15 seconds West, a distance of 37.41 feet to an iron pin set; thence South 16 degrees 50 minutes 06 seconds West, a distance of 20.85 feet to an iron pin found at the northeast corner of aforesaid 0.90 acre tract; thence along the east line of said 0.90 acre tract South 0 degrees 00 minutes 18 seconds East, a distance of 149.98 feet to the POINT OF BEGINNING and containing 2.348 acres, and being a part of a 2.94 acre tract described in Volume 208 Page 521 of the Athens County Deed Records, and being all of a 0.90 acre tract described in Volume 306 Page 507 of the Athens County Official Deed Records.

Commencing at an iron pin set on the north right of way line of Mulligan Road at the southeast corner of a 2.94 acre tract described in Volume 208 Page 521 of the Athens County Deed Records; thence along the north right of way line of said road on an assumed bearing North 73 degrees 14 minutes 55 seconds West, a distance of 70.00 feet to an iron pin set , THE TRUE POINT OF BEGINNING; thence continuing along said north right of way line, North 73 degrees 14 minutes 56 seconds West a distance of 83.00 feet to a point at the southeast corner of a 0.90 acre tract described in Volume 306 Page 507 of the Athens County Deed Records, said point is witnessed by a found, bent iron pin which bears South 55 degrees 29 minutes 14 seconds West 1.13 feet; thence leaving the north right of way line and along the east line of said 0.90 acre tract the following two bearings and distances: North 0 degrees 00 minutes 18 seconds West, a distance of 149.98 feet to an iron pin found; thence North 16 degrees 50 minutes 06 seconds East, a distance of 20.85 feet to an iron pin set; thence along a random line the following two bearings and distances: South 61 degrees 35 minutes 49 seconds East, a distance of 110.81 feet to an iron pin set; thence South 9 degrees 39 minutes 29 seconds West, a distance of 143.18 feet to an iron pin set at the POINT OF BEGINNING and containing 0.340 acre, and being a part of a 2.94 acre tract described in Volume 208 Page 521 of the Athens County Deed Records.

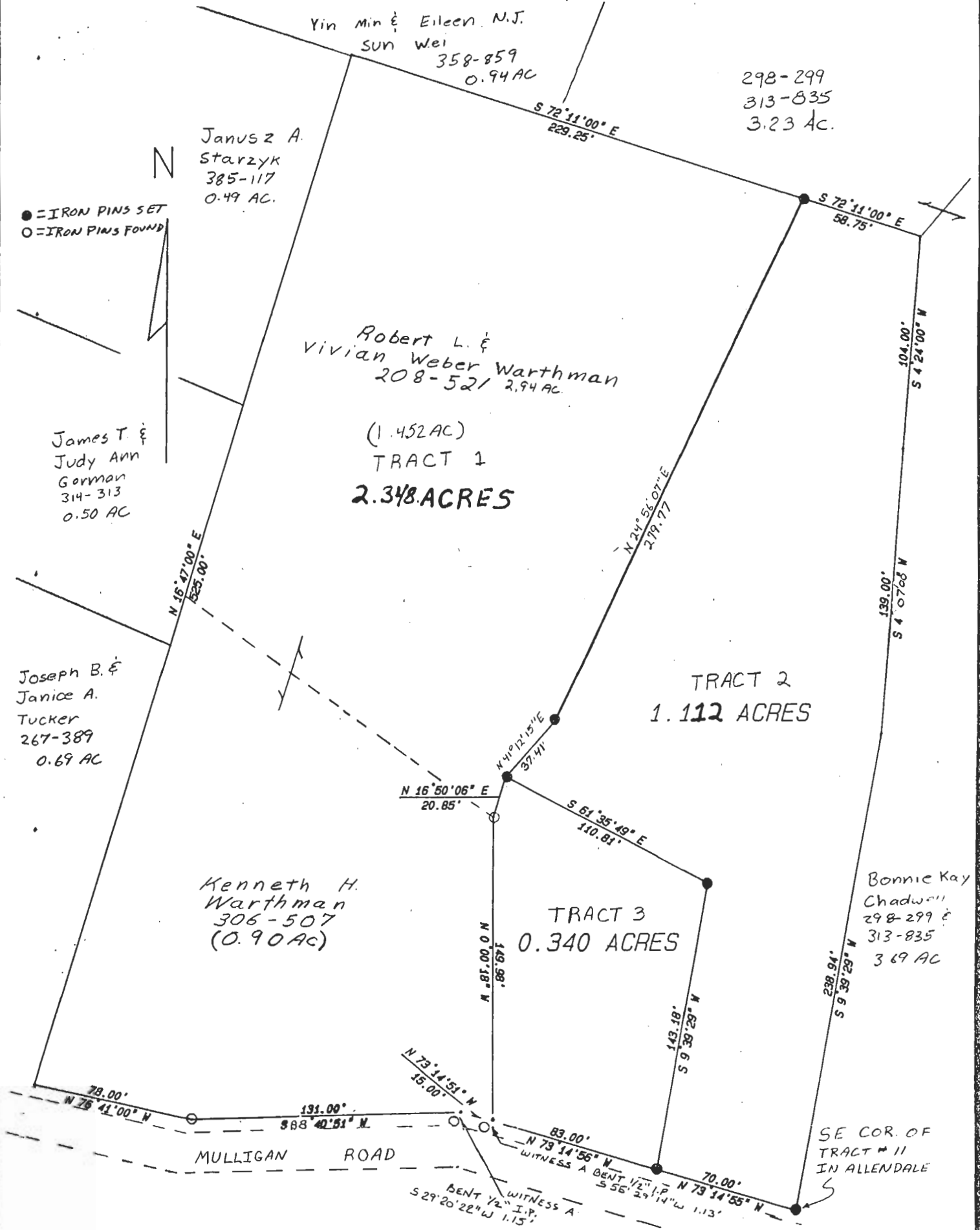
