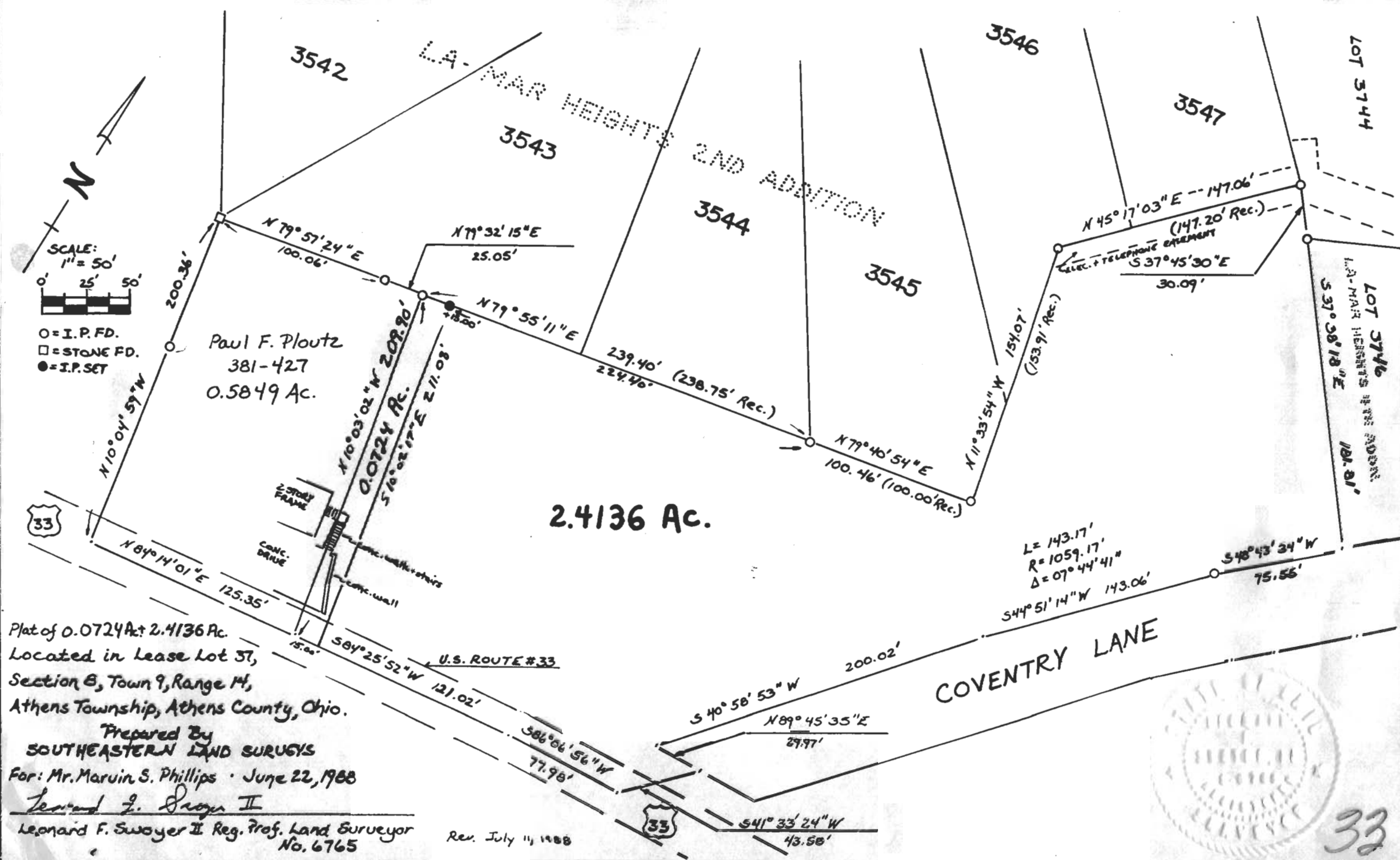
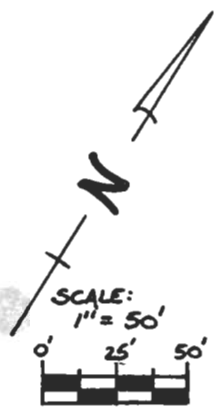

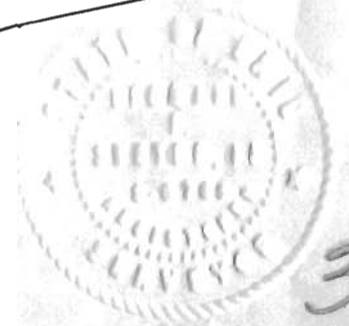


Plat of 0.0724 Ac. & 2.4136 Ac.
