## Legal Description 0.263 Acres

All of Elizabeth L. Crockett & R. Patrick Hassett Parcel: O.R. Book 397, Page 1609

Situated in the City of Athens, County of Athens, State of Ohio, Township 9N, Range 14W, and being all of Lot 964 and part of a vacated alley as shown on the Plat of C.H. Grosvenor's Addition, as recorded in Plat Book 3, Page 85, in the Athens County Plat Records, and being more particularly described as follows;

Being a Survey of 2 parcels conveyed to Elizabeth L. Crockett & R. Patrick Hassett, as recorded in O.R. Book 397, Page 1609, in the Athens County Deed Records, and being all of Auditor's P.P.N. A02-82700004-00 & P.P.N. A02-82700005-00, and further described as follows;

Commencing at a point on the West Right of Way Line of East State Street (66' Wide R/W) marking the Southeast corner of said Lot 964 of which this description is a part, the same being the Northeast corner of Lot 963 and a parcel conveyed to Nicholas E. Gatzulis, ETAL, as recorded in O.R. Book 500, Page 2070, and being the **PRINCIPLE PLACE OF BEGINNING** of the **0.263 Acre** parcel herein to be described: said point bears N 35°03'06" E 47.91 feet from a 5/8" o.d. iron pin found;

Thence, N 54°55'53" W 184.95 feet leaving East State Street with the South line of said Lot 964, the same being the North line of Lot 963 and said parcel conveyed to Gatzulis, ETAL (O.R.500,Pg., 1609) and extending along the North line of a parcel conveyed to Judith Svendsen, as recorded in O.R. Book 317, Page 351, to an iron pin set on the East Right of Way line of Franklin Avenue (50' Wide R/W), and passing over a 5/8" o.d. iron in found at 1.47 feet: said iron pin set bears N 34°58'38" E 91.60 feet from a 5/8" o.d. iron in found;

Thence, N 34°58'38" E 62.00 feet with the West line of said 964, the same being the East Right of Way Line of said Franklin Avenue, to an iron pin set in the centerline of said vacated alley, and being the Southwest corner of said alley part conveyed to Janja & Srdjan Nesic, as recorded in O.R Book 293, Page 2218, and passing over a 5/8" o.d. iron pin found at 2.72' North and 0.55' East of the Right of Way Line of Franklin Avenue;

Thence, S 54°57'31" E 185.03 feet leaving Franklin Avenue with the centerline of said vacated alley, the same being the Southwest corner of said alley part conveyed to Nesic (O.R.293,Pg.2218), to an iron pin set on the West Right of Way Line of said East State Street;

Thence, S 35°03'06" W 62.09 feet with the West Right of Way Line of said East State Street, the same being the East line of said alley and extending along the East line of said Lot 964 of which this description is a part, to the <a href="PRINCIPLEPLACE">PRINCIPLEPLACE</a>
OF BEGINNING, and containing 0.263 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions and ordinances of record.

Bearings of the above description are based on the O.D.O.T. CORS Network System, Ohio State Plane Coordinate System South Zone. 2011(NAD83).

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452".
