**S 52° 33' 26" E, 219.89 feet** to a magnail set;

Thence along new lines create by this survey,

**S 35° 51' 50" W, 229.27 feet** to an iron pin set;

**N 65° 11' 21" W, 267.74 feet** to the Point of Beginning and **containing 1.418 acres.**
