## DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Mark J. Howdyshell Trustee OR 203 Pg. 629, being part of Fraction 1, and more particularly described as follows:

( Tract 7 ) Beginning at an iron pin found at the Northeast Corner of Fraction 1; thence along the East line of Fraction 1 South 00 Degrees 37 Minutes 40 Seconds East 1103.76 feet to an iron pin found; thence South 89 Degrees
12 Minutes 51 Seconds West 513.34 feet to an iron pin found
and the place of beginning; thence South 00 Degrees 46 Minutes 19 Seconds East 1054.34 feet to an iron pin found; thence North 55 Degrees 50 Minutes 56 Seconds West 1747.58 feet to a point in the centerline of Twp. Rd. 196, passing an iron pin set at 1717.58 feet; thence along said centerline the next 5 courses to points: North 18 Degrees 58 Minutes 17 Seconds East 262.06 feet; thence North 34 Degrees 38 Minutes 35 Seconds East 234.33 feet; thence North 40 Degrees 42 Minutes 51 Seconds East 108.66 feet; thence North 33 Degrees 14 Minutes 57 Seconds East 179.96 feet; thence North 35 Degrees 38 Minutes 04 Seconds East 125.36 feet; thence leaving said centerline South 54 Degrees 07 Minutes 46 Seconds East 1198.30 feet to the place of beginning, passing an iron pin set at 10.35 feet, containing 30.24 acres, more or less, subject to all legal highways and easements.

Bearings are based on the East line of Fraction 1 as being South 00 Degrees 37 Minutes 40 Seconds East.


