## **DESCRIPTION OF 20.669 Acres**

thence, from said Point of Beginning and running with the south line of said Brown tract, North 89°14'20" East a distance of 1,740.86 feet to an iron pin set in the west line of a 14 acres tract as conveyed to Melvin R. and Darlene Norris by Deed Volume 338, Page 833 of the Athens County Recorder's Office, passing through four iron pins set at distances of plus 267.24 feet, plus 909.86 feet, plus 1,228.86 feet, and plus 1,581.86 feet, respectively, and passing through four iron pins found capped "Bayha 6139" at distances of plus 517.24 feet, plus 744.21 feet, plus 1,085.64 feet, and plus 1,400.16 feet, respectively;

thence, with the west line of said Norris tract, South 00°06'35" East a distance of 371.08 feet to an iron pin set at the northeast corner of a 1 acre tract as conveyed to Elza Hill by Deed Volume 117, Page 387 of the Athens County Recorder's Office, passing through an iron pin set at a distance of 164.08 feet;

thence, with the north line of said Hill tract, South 86°47′21" West a distance of 228.24 feet to an iron pin set at the northwest corner of said Hill tract;

thence, with the west line of said Hill tract, South 03°19'30" East a distance of 224.76 feet to a point in the centerline of Township Road No. 206 (Sweat Road), passing through an iron pin set at a distance of plus 203.76 feet;

thence, with the centerline of Township Road No. 206, the following 13 courses:

- 7. thence North 77°20'20" West a distance of 199.65 feet to a point;
- 8. thence North 77°14'48" West a distance of 171.96 feet to a point;
- 9. thence North 77°10'59" West a distance of 148.89 feet to a point;
- 10. thence North 76°25'12" West a distance of 130.28 feet to a point;
- 11. thence North 71°11'05" West a distance of 80.33 feet to a point;

- 12. thence North 63°34'00" West a distance of 66.15 feet to a point;
- 13. thence North 55°13'06" West a distance of 40.01 feet to a point in the west line of the northwest quarter of Section 17;

thence, with the section line, North 00°06'35" West a distance of 342.76 feet to the Point of Beginning, passing through two iron pins set at distances of plus 30.00 feet and plus 186.00 feet, respectively;

Containing 20.669 acres, more or less.

Subject to all legal right-of-ways, easement, restrictions, reservations, and zoning regulations of record.

Subject to the right-of-way of Township Road No. 206 (Sweat Road).

Subject to the 100-Year Flood Plain restrictions, if applicable.
