DESCRIPTION OF A 37.705 ACRE TRACT

Situated in Section 19, Town 7, Range 12, Bern Township, Athens County, Ohio, and being the tracts described in Volume 385 Page 619 Athens County Deed Records and a part of the tracts described in Volume 229 Page 144 Official Records of Athens County and being more particularly described as follows:

Commencing at an iron pin found at the Southeast Corner of Section 19, said iron pin being the POINT OF BEGINNING of the following described tract;

thence, following the South line of said Section 19, North 87 degrees 27 minutes 53 seconds West, a distance of 2330.86 feet to an iron pin set;

thence, leaving said line on a random line, North 30 degrees 33 minutes 01 second West, a distance of 279.26 feet to an iron pin set;

thence North 46 degrees 58 minutes 53 seconds East, a distance of 499,67 feet to an iron pin set; thence South 87 degrees 27 minutes 53 seconds East, a distance of 1560.36 feet to an iron pin set; thence North 2 degrees 55 minutes 18 seconds East, a distance of 330.00 feet to an iron pin set, passing an iron pin found at 25.04 feet;

thence North 72 degrees 25 minutes 18 seconds East, a distance of 342.66 feet to an iron pin set; thence North 2 degrees 55 minutes 18 seconds East, a distance of 9.39 feet to an iron pin set; thence North 71 degrees 25 minutes 18 seconds East, a distance of 275.22 feet to an iron pin found in the East line of Section 19;

thence, following said line, South 2 degrees 55 minutes 18 seconds West, a distance of 1147.08 feet to the POINT OF BEGINNING; said described tract containing 37.705 acres (1,642,427.8744 square feet).

Situated in Section 19, Town 7, Range 12, Bern Township, Athens County, Ohio, and being a part of a 19.80 acre tract described in Volume 229 Page 144 Athens County Deed Records and being more particularly described as follows:

Commencing at an iron pin found at the Southwest Corner of The Southeast Quarter of Section 19; thence, North 46 degrees 58 minutes 53 seconds East, a distance of 327.74 feet to an iron pin set, passing an iron pin found at 158.73 feet;

thence South 30 degrees 33 minutes 01 second East, a distance of 279.26 feet to an iron pin set in the South line of said Section 19;

thence, following said Section line, North 87 degrees 27 minutes 53 seconds West, a distance of 381.94 feet to the POINT OF BEGINNING; said described tract containing 1.026 acres (44,683.1028 square feet) and is to be continuous and contiguous with a 181 acre tract described in Volume 293 Page 2433 Official records of Athens County.
