DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Mark Howdyshell Trustee OR 203 Pg. 629, being part of Fraction 19, and more particularly described as follows:

Beginning at an iron pin found at the Northeast Corner of Fraction 19; thence along the North line of Fraction 19 South 89 Degrees 04 Minutes 45 Seconds West 2078.50 feet to a point; thence South 54 Degrees 35 Minutes 39 Seconds West 409.78 feet to an iron pin set and the place of beginning; thence South 48 Degrees 10 Minutes 55 Seconds West 850.60 feet to a railroad spike set in the centerline of St. Rt. 329; thence along said centerline North 69 Degrees 23 Minutes 10 Seconds West 56.40 feet to a PK nail set; thence leaving said centerline North 48 Degrees 10 Minutes 55 Seconds East 888.02 feet to an iron pin set; thence South 29 Degrees 04 Minutes 01 Seconds East 51.26 feet to the place of beginning, containing 1.00 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the North Line of Fraction 19 as being South 89 Degrees 04 Minutes 45 Seconds West.


