DEED DESCRIPTION *207.81 acres*



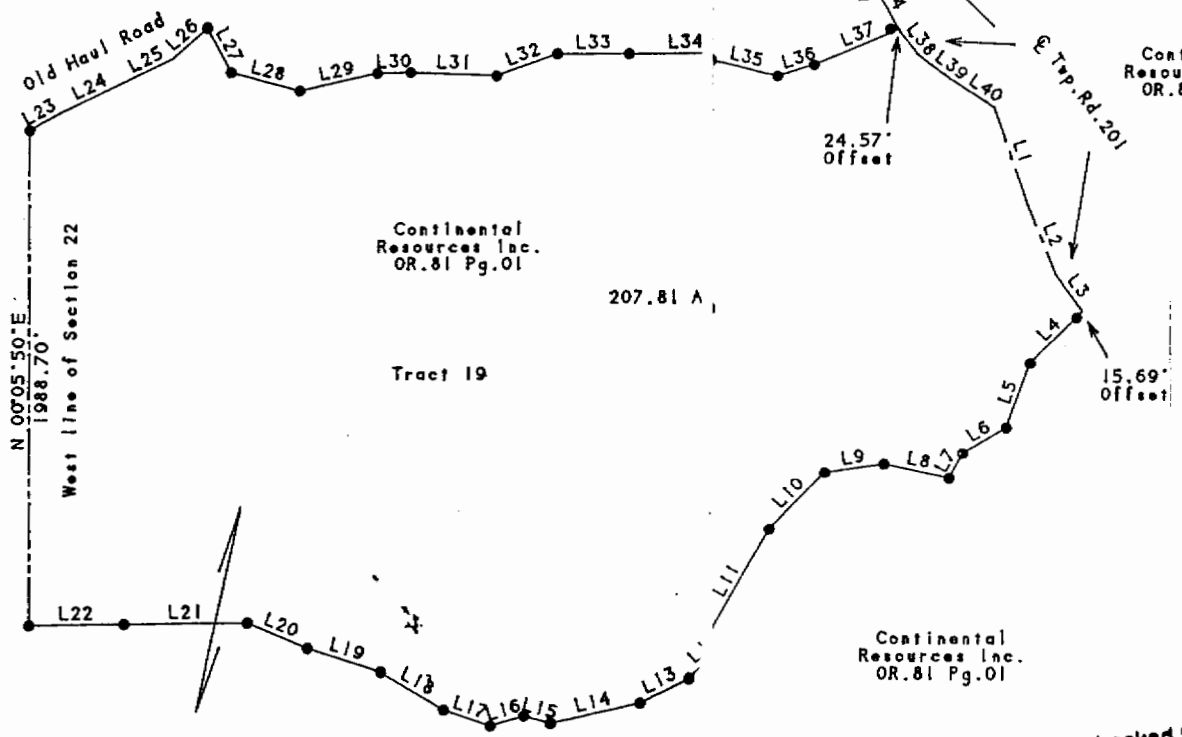

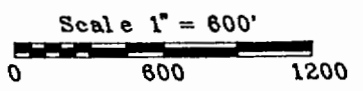
