DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Mark J. Howdyshell OR 203 Pg. 629, being part of Fractional Section 18, and more particularly described as follows:

Beginning at an iron pin found at the Southwest Corner of Fractional Section 18; thence North 01 Degrees 19 Minutes 58 Seconds West 691.04 feet to a point in the centerline of Twp. Rd. 201 and the place of beginning, passing an iron pin found at 675.00 feet; thence continuing along the West line of Fractional Section 18 North 01 Degrees 19 Minutes 58 Seconds West 2491.44 feet to an iron pin set, passing an iron pin set at 26.96 feet; thence along a ravine the following 7 couseses: South 27 Degrees 16 Minutes 31 Seconds East 309.05 feet to an iron pin set; thence South 27 Degrees 16 Minutes 31 Seconds East 246.02 feet to an iron pin set; thence South 53 Degrees 24 Minutes 41 Seconds East 165.56 feet to an iron pin set; thence South 35 Degrees 12 Minutes 28 Seconds East 282.30 feet to an iron pin set; thence South 31 Degrees 46 Minutes 23 Seconds East 457.40 feet to an iron pin set; thence South 17 Degrees 22 Minutes 45 Seconds East 238.24 feet to an iron pin set; thence South 03 Degrees 55 Minutes 52 Seconds East 625.79 feet to a point in the centerline of Twp. Rd. 201, passing an iron pin set at 592.71 feet; thence along said centerline the following 5 courses to points: North 88 Degrees 00 Minutes 18 Seconds West 191.40 feet; thence South 75 Degrees 53 Minutes 45 Seconds West 61.18 feet; thence South 56 Degrees 25 Minutes 07 Seconds West 181.30 feet; thence South 53 Degrees 13 Minutes 51 Seconds West 403.86 feet; thence South 57 Degrees 37 Minutes 29 Seconds West 144.28 feet to the place of beginning, containing 29.50 acres, more or less, subject to all legal highways and easements.




