DEED DESCRIPTION

Situated in the State of Chio, County of Athens, Township of Bern, T-7, R-14, being a part of Continental Resources Inc. OR 81 Pg. 01, being part of the Northeast Quarter of Section 23, and more particularly described as follows:

(TRACT 10) Beginning at an iron pin set at the Northwest Corner of the Northeast Quarter of Section 23; thence South 22 Degrees 37 Minutes 17 Seconds East 1066.74 feet to a 22 Degrees 37 Minutes 17 Seconds East 1066.74 feet to a point in the centerline of State Route 550 and the place of beginning; thence along said centerline the next 3 courses to points: South 70 Degrees 15 Minutes 55 Seconds East 163.07 feet; thence South 58 Degrees 47 Minutes 57 Seconds East 653.66 feet; thence South 50 Degrees 41 Minutes 54 Seconds East 73.35 feet; thence leaving said road South 44 Degrees 22 Minutes 11 Seconds West 611.08 feet to an iron pin set, passing an iron pin set at 23.22 feet; thence South 70 Degrees 10 Minutes 18 Seconds West 603.36 feet to an iron pin set; thence Morth 17 Degrees 09 Minutes 23 Seconds West 319.41 feet to an iron pin set; thence North 16 Degrees 28 Minutes 58 Seconds East 433.05 feet; thence North 28 Degrees 35 Minutes 51 Seconds East 411.36 feet to North 28 Degrees 35 Minutes 51 Seconds East 411.36 feet to the place of beginning, passing an iron pin set at 384.65 feet, containing 15.29 acres, more or less, subject to all legal highways and essements.


