DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-14, being a part of Continental Resources Inc. OR 81 Pg. 01, being part of the East Half of Section 23, and more particularly described as follows:

(TRACT 17) Beginning at a railroad iron found at the Southeast Corner of Section 23; thence North 82 Degrees 47 Minutes 08 Seconds West 470.43 feet to an iron pin set and the place of beginning; thence North 82 Degrees 47 Minutes 08 Seconds West 1068.33 feet to a point in the centerline of Twp. Rd. 201, passing an iron pin set at 1047.13 feet; thence along said road the next 6 courses to points: North 34 Degrees 28 Minutes 05 Seconds East 211.01 feet; thence North 35 Degrees 06 Minutes 48 Seconds East 236.98 feet; thence North 37 Degrees 11 Minutes 23 Seconds East 294.34 feet; thence North 48 Degrees 01 Minutes 13 Seconds East 352.15 feet; thence North 36 Degrees 21 Minutes 49 Seconds East 153.95 feet; thence North 16 Degrees 50 Minutes 00 Seconds East 19.39 feet; thence leaving said road South 59 Degrees 30 Minutes 12 Seconds East 124.78 feet to an iron pin set, passing an iron pin set at 18.95 feet; thence South 44 Degrees 03 Minutes 04 Seconds East 313.86 feet to an iron pin set; thence South 46 Degrees 56 Minutes 02 Seconds East 115.86 feet to an iron pin set; thence South 11 Degrees 12 Minutes 42 Seconds West 364.78 feet to an iron pin set; thence South 07 Degrees 59 Minutes 42 Seconds West 318.27 feet to an iron pin set; thence South 20 Degrees 36 Minutes 21 Seconds West 78.54 feet to the place of beginning, containing 17.93 acres, more or less, subject to all legal highways and easements.
