DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Reme, T-7, R-12, being a part of Mark Howdyshell Trustee OR 203 Pg. 579, being part of the Northwest Quarter of Section 7, and more particularly described as follows:

Beginning at an iron pin found at the Northwest Corner of Section 7; thence along the North line of Section 7 North 89 Degrees 57 Minutes 24 Seconds East 1432.37 feet to a point in the centerline of Co.
