DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Bern, T-7, R-12, being a part of Mark J. Howdyshell Trustee OR 203 Pg. 629, being part of Fraction 2, and more particularly described as follows:

(TRACT 5) Beginning at a stone at the Northeast Corner of Fraction 2; thence along the East line of Fraction 2 South 00 Degrees 21 Minutes 03 Seconds East 2422.20 feet to an iron pin set, passing an iron pin set at 1973.40 feet; thence North 88 Degrees 55 Minutes 29 Seconds West 1369.41 feet to an iron pin set and the place of beginning; thence North 88 Degrees 55 Minutes 29 Seconds West 1531.78 feet to an iron pin set; thence North 00 Degrees 28 Minutes 14 Seconds West 763.64 feet to a point in the centerline of Twp. Rd. 196, passing an iron pin set at 727.15 feet; thence along said centerline the next 6 courses to points: North 41 Degrees 40 Minutes 14 Seconds East 158.95 feet; thence North 60 Degrees 19 Minutes 04 Seconds East 78.69 feet; thence North 74 Degrees 24 Minutes 14 Seconds East 73.87 feet; thence North 81 Degrees 06 Minutes 18 Seconds East 401.28 feet; thence North 79 Degrees 20 Minutes 37 Seconds East 237.00 feet; thence North 79 Degrees 43 Minutes 55 Seconds East 364.80 feet; thence leaving said centerline South 14 Degrees 56 Minutes 01 Seconds East 1180.69 feet to the place of beginning, passing an iron pin set at 30.00 feet, containing 32.39 acres, more or less, subject to all legal highways and easements.
