Commencing at a 24 inch beech corner tree at the northeast corner of said Section 18; thence along the north line of Section 18 on an assumed bearing North 83°11'10" West 2,864.75 feet to a point; thence South 13°37'28" West 460.44 feet to a point in Athens County Road 34, said point is THE POINT OF BEGINNING; thence South 49°22'32" East 134.00 feet to a point; thence South 83°42'45" East 73.50 feet to a set railroad spike in said Athens County Road 34; thence leaving said road and along the west line of a 90.38 acre tract described in Volume 221 Page 197 of the Athens County Deed Records South 01°21'46" East 449.47 feet to a set iron pin; thence continuing along the west line of said 90.38 acre tract South 03°55'34" West 910.90 feet to a set iron pin; thence leaving the west line of said 90.38 acre tract and along the northerly line of a 189.15 acre tract described in Volume 160 Page 312 of the Athens County Deed Records North 82°48'08" West 1,557.84 feet to a set iron pin; thence leaving the northerly line of said 189.15 acre tract and along the east line of an 80 acre tract described in Volume 383 Page 745 of the Athens County Deed Records North 05°56'52" East 1,875.51 feet to a set railroad spike in aforesaid Athens County Road 34; thence along said road on a random line the following nine bearings and distances:

- 2) South 43°41'12" East 125.64 feet to a point; thence
- 3) South 59°43'27" East 167.09 feet to a point; thence
- 4) South 75°50'50" East 231.19 feet to a point; thence

- 6) South 64°44'25" East 266.69 feet to a point; thence
