

## SOUTHEASTERN LAND SURVEYS

Situated in the southwest quarter of Section 5, Town 5, Range 614793-8701 Canaan Township, Athens County, Ohio and described as follows:

Commencing at the northwest corner of Section 5; thence on an assumed bearing South 86 degrees 59 minutes 34 seconds East, a distance of 428.00 feet to a point; thence South 3 degrees 25 minutes 35 seconds West, a distance of 2640.85 feet to a point in the middle of said Section 5; thence along the middle line of said Section South 88 degrees 28 minutes 15 seconds East, a distance of 1470.52 feet to a point in the middle of Athens County Road 34; thence along said road South 12 degrees 15 minutes 06 seconds East, a distance of 142.69 feet to the southeast corner of a 5.00 acre tract entitled as Tract D of the tracts of land described in Volume 124 Page 744 of the Athens County Official Deed Records, said point is THE TRUE POINT OF BEGINNING; thence continuing along said road the following five bearings and distances: 1) South 45 degrees 23 minutes 11 seconds East, a distance of 26.82 feet to a point; thence 2) South 22 degrees 36 minutes 24 seconds East, a distance of 188.35 feet to a point; thence 3) South 27 degrees 41 minutes 13 seconds East, a distance of 125.16 feet to a point; thence 4) South 38 degrees 09 minutes 43 seconds East, a distance of 61.14 feet to a point; thence 5) South 42 degrees 58 minutes 27 seconds East, a distance of 71.21 feet to a point; thence leaving said road on an arbitrary line the following two bearings and distances: 1) South 26 degrees 31 minutes 48 seconds West, passing a set iron pin at 14.32 feet, for a total distance of 268.53 feet to an iron pin set on the bank of a creek; thence 2) leaving said creek North 81 degrees 24 minutes 17 seconds West, a distance of 424.84 feet to a point at the southeast corner of a 5.0 acre tract described in Volume 104 Page 765 of the Athens County Official Deed Records; thence along the east line of said 5.0 acre tract North 6 degrees 44 minutes 02 seconds East, a distance of 390.49 feet to an iron pin\* at the southwest corner of aforesaid Tract D; thence leaving the east line of the 5.0 acre tract described in Volume 104 Page 765 and along the south line of said Tract D North 53 degrees 16 minutes 28 seconds East, passing an iron pin\* at 307.21 feet, for a total distance of 322.21 feet to the POINT OF BEGINNING and containing 5.153 acres, and being a part of a 15.80 acre tract described as the second tract in Volume 299 Page 175 of the Athens County Deed Records.

\*denotes calculated location of iron pin based on previous survey

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


