BEGINNING, FOR REFERENCE, AT A STONE FOUND MARKING THE NORTHWEST CORNER OF THE SOUTH WEST QUARTER OF SECTION 8, TOWNSHIP 5, RANGE 13, THENCE S 83° 39' 45" E 3422.43 TO AN IRON PIN SET, SAID POINT BEING IN THE NORTH LINE OF THE SHEETER PARCEL AND BEING THE PRINCIPLE PLACE OF BEGINNING FOR THE TRACT HERE IN TO BE DESCRIBED:

THENCE, CONTINUING WITH THE NORTH LINE OF THE SHEETER PARCEL S 83° 39' 45" E 637.20 FEET TO AN IRON PIN SET, SAID POINT BEING IN THE WEST LINE OF A PARCEL CONVEYED TO RICHARD T. DYBIEC AS RECORDED IN DEED VOLUME 364 PAGE 877 OF THE ATHENS COUNTY RECORDER'S OFFICE:

 06° 37' 33" E 2062.78 FEET TO THE PLACE OF BEGINNING, SAID PARCEL
 CONTAINS 53.6900 ACRES MORE OF LESS, SUBJECT TO ALL LEGAL
 EASEMENTS OF RECORD.
