## Legal Description 1.923 Acres Part Conrad J. Josten Parcels:

Situated in the Township of Canaan, County of Athens, State of Ohio, and being a part of the Southwest Quarter of Section 32, Township 5N, Range 13W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of a part of 3 parcels conveyed to Conrad J. Josten, as recorded in O.R. Book 223, Page 263 (P.P.N. E020020007100), O.R. Book 234, Page 297 (P.P.N. E020020006900), and O.R. Book 329, Page 757 (P.P.N. E020020007000), in the Athens County Deed Records, and further described as follows;

Commencing at a 3/4" o.d. iron pipe on the West line of Section 32 of Canaan Township marking the Northwest corner of a 24.76 Acre parcel conveyed to Shannon Richmond, Trustee, as recorded in O.R. Book 335, Page 2069, also being on the East line of Section 2 of Athens Township and a 96.41 Acre parcel conveyed to Bernard B. & Carol L. Grueser, as recorded in O.R. Book 37, Page 276; said pipe bears North 628.94 feet from the Southwest corner of Section 32 (by Deed);

Thence, N 00°21'25" E 207.75 feet with the West line of Section 32 of Canaan Township, the same being the East line of Section 2 of Athens Township and said 96.41 Acre parcel conveyed to Grueser (OR37,Pg.276), to a 1/2" o.d. iron pin found, and being the PRINCIPLE PLACE OF BEGINNING of the 1.923 Acre parcel herein to be described;

Thence, N 00°04'50" W 173.82 feet continuing with the West line of Section 32 of Canaan Township, the same being the East line of Section 2 of Athens Township and said 96.41 Acre parcel conveyed to Grueser (OR37,Pg.276), to a 3/4" o.d. iron pipe found, marking the Southwest corner of a 2.90 Acre parcel conveyed to Bernard B. Grueser, as recorded in O.R. Book 16, Page 252;

Thence, S 84°30'00" E 628.02 feet with the South line of said 2.90 Acre parcel conveyed to Grueser (OR16,Pg.252), to a 1/2" o.d. iron pin found in the centerline of Angel Ridge Road (Co. Road 98), and passing over a 5/8" o.d. iron pin found at 502.96 feet & S 05°30'00" W 0.60 feet South of line;

Thence, S 31°56'01" E 39.76 feet with the centerline of Angel Ridge Road, to a mag nail set;

Thence leaving Angel Ridge Road with a line across said parcels conveyed to Josten (O.R. 223,Pg.263, O.R.234,Pg.297, & O.R.329,Pg.757), with the following three (3) courses and distances:

- 1) S 51°57'53" W 154.30 feet to an iron pin set, passing over a mag nail set at 30.00 feet and passing over an iron pin set at 57.90 feet;
- 2) N 27°29'28" W 35.60 feet to an iron pin set;
- 3) S 88°09'06" W 508.21 feet to the PRINCIPLE PLACE OF BEGINNING, and passing over a 5/8" o.d. iron pin found at 308.71 feet.;

Said parcel as surveyed contains 1.923 Acres, more or less, and is subject to all legal easements, right of ways, restrictions, and zoning ordinances of record.



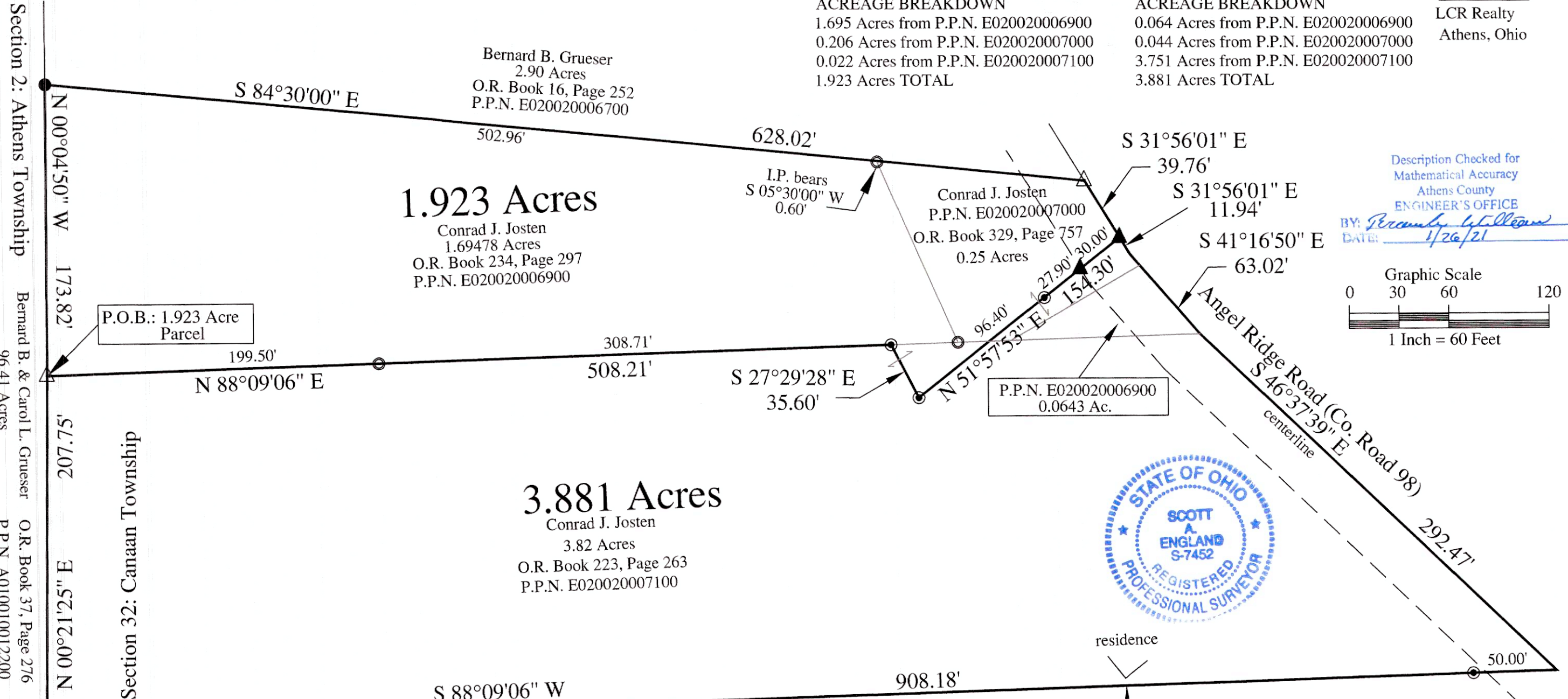

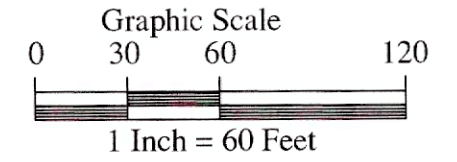
