Beginning for reference at an existing railroad spike being the northeast corner of said Section 5, T-10, R-12, said spike also being a point in the centerline of County Road 64, Mountain Belle Road;

Thence along said centerline the following five courses;

- 1. South62°14'26"West, a distance of 103.21 feet to a point;
- 2. South48°16'37"West, a distance of 254.85 feet to a point;
- 3. South35°04'30"West, a distance of 107.30 feet to a point;
