NON-BUILDING SITE PARCEL - ADJOINING PROPERTY OWNER TRANSFER

Situate in the West one-half ($\frac{1}{2}$) of Section 34, Town 5, Range 12, Carthage Township, Athens County, State of Ohio and being more particularly described as follows:

Commencing at the Northwest corner of Section 34; thence S $07^{\circ}26'20''$ W along the West line of said Section 34; said line also being the Carthage Township - Lodi Township line, 1,390.4 feet to an iron bolt found in the Northwest corner of a 41.19 acre tract owned by James & Helen Norton as recorded in Deed Book 314, Page 1 in the Athens County Recorder's Office, Athens County, Ohio; thence N $88^{\circ}35'00''$ E along the North line of said 41.19 acre tract, 404.35 feet to an iron bolt found in the Northeast corner of said 41.19 acre tract, said iron bolt found also being in the centerline of Carthage Township Road No. 103; thence S $06^{\circ}44'15''$ E, 169.49 feet to an iron bolt found at an angle point in said line, passing through a railroad spike set in the Northwest corner of a 20.0145 acre tract surveyed by me on 9 November 1978 at 84.15 feet; thence S $13^{\circ}25'00''$ E continuing along the previously described line and the West line of said 20.0145 acre tract, 713.56 feet to a railroad spike set in the Southwest corner of said 20.0145 acre tract, said railroad spike set also being the real point of beginning of the parcel herein described:

Thence S $76^{\circ}03'44''$ E along the South line of said 20.0145 acre tract, 168.63 feet to an iron bar found in the most Northerly Northwesterly corner of a 9.56 acre tract owned by Leonard and Patty Zimmerman as recorded in Deed Book 343, Page 765 in said Recorder's Office, passing through an iron pipe set for reference at 15.00 feet; thence S $12^{\circ}03'05''$ E along one of the Northwesterly lines of said 9.56 acre tract, 132.14 feet to an iron bar found (previous survey and deed calls this distance to be 132.20 feet); thence S $65^{\circ}42'01''$ W continuing along another of the Northwesterly lines of said 9.56 acre tract, 156.35 feet to an iron bar found in the most Westerly Northwest corner of said 9.56 acre tract, the centerline of said Carthage Township Road No. 103 and the East line of said 41.19 acre tract; thence N $20^{\circ}26'25''$ W along said centerline of said Carthage Township Road No. 103 and the said East line of said 41.19 acre tract, 97.62 feet to an iron bolt found at an angle point in said line; thence N $13^{\circ}25'00''$ W continuing along a previously described line, 63.20 feet to the point of beginning and containing 0.5504 acre.

The above described 0.5504 acre parcel is an adjoining property owned transfer that is to be held in contiguous and continuous ownership with the existing Grantee's 9.56 acre tract and is intended to square up the existing Northwest corner of said 9.56 acre tract.
