## EXHIBIT A Description of survey for Matt Clark

Being a tract of land transferred to Robert Ray and Julie Ann Stack as recorded in Official Records Volume 64 at page 301 Athens County Recorder's Office, Athens County, Ohio, also being a part of Section 6, Township-5, Range-12, Carthage Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at a 5/8" iron pin set assumed to be the northeast corner of the southwest Quarter of said Section 6, T-5, R-12;

Thence along the west line of a tract transferred to Martin Gainer as recorded in Official Records Volume 345 at page 902 South00°00'00"East, a distance of 1622.92 feet to a 48" white oak tree;

Thence leaving said west line and along an ancient wire fence assumed to be the north line of a tract transferred to Karen Hiehle as recorded in Official Records Volume 71 at page 783 the following nine courses;

- 1. South88°04'17"West, a distance of 135.82 feet to an existing wooden post;
- 2. North87°01'38"West, a distance of 171.11 feet to a 6" elm tree;
- 3. North79°11'57"West, a distance of 53.61 feet to a 20" red oak tree;
- 4. South85°13'43"West, a distance of 142.69 feet 28" white oak tree;
- 5. South86°43'12"West, a distance of 123.89 feet to a 60 penny nail at a stump;
- 6. North89°03'24"West, a distance of 124.08 feet to a 36" tulip tree;
- 7. North72°53'44"West, a distance of 42.60 feet 15" red oak tree;
- 8. North86°24'50"West, a distance of 85.06 feet to a 6" hickory tree;
- 9. South89°04'43"West, a distance of 58.07 feet to a 5/8" iron pin set in the centerline of a creek;

Thence leaving said ancient wire fence and along the centerline of said creek being the boundary of a tract transferred to Scott Graybill etal as recorded in Official Records Volume 461 at page 1547 the following three courses;

- 1. North24°53'47"East, a distance of 116.84 feet to a point;
- 2. North22°56'08"West, a distance of 135.77 feet to a point;
- 3. North22°17'49"East, a distance of 68.89 feet to a 5/8" iron pin set;

Thence leaving the centerline of said creek and continuing along said Graybill boundary North56°48'58"West, a distance of 98.98 feet to a 60 penny nail set in the centerline of County Road 65, Deep Hollow Road;

Thence leaving said Graybill boundary and along the centerline of County Road 65 the following six courses;

- 1. North33°11'02"East, a distance of 46.21 feet to a point;
- 2. North42°23'08"East, a distance of 46.82 feet to a point;
- 3. North47°08'43"East, a distance of 130.75 feet to a point;
- 4. North31°44'39"East, a distance of 108.43 feet to a point;
- 5. North10°49'21"East, a distance of 168.71 feet to a point;
- 6. North16°17'38"East, a distance of 93.87 feet to a point being the intersection of said centerline and the centerline of Township Road 150, Sand Rock Road;

Thence leaving said County Road 65 and along the centerline of said Township Road 150 the following six courses;

1. North49°01'00"West, a distance of 135.41 feet to a point;

- 3. North62°35'29"West, a distance of 98.50 feet to a point;
- 4. North69°50'35"West, a distance of 139.28 feet to a point;
- 5. North71°53'53"West, a distance of 115.19 feet to a point;
- 6. North66°40'11"West, a distance of 77.71 feet to a point;

Thence leaving said centerline and along the east line of a tract transferred to Matthew Brunty as recorded in Official Records Volume 149 at Page 746 North00°10'51"East, passing thru an existing iron pipe at a distance of 11.32 feet and going a total distance of 451.42 feet to a 5/8" iron pin set on the south line of a tract transferred to Brian Miller as recorded in Official Records Volume 332 at page 1209;

Thence leaving said Brunty boundary and along the south line of said Miller tract South89°49'09"East, a distance of 1295.66 feet to the principal point of beginning containing 37.2139 acres more or less subject to all legal easements and rights of way.
